**SELECTION OF AREAS AND PROJECTS UNDER PMJVK**

1718. SHRI SUBHASH BARALA:  
SHRI MAHARAJA SANAJAOBA LEISHEMBA:

Will the Minister of MINORITY AFFAIRS be pleased to state:-

- (a) the criteria adopted for identifying areas and selecting projects for implementation under the Pradhan Mantri Jan Vikas Karyakram (PMJVK) ;
- (b) the process followed for submission, appraisal and approval of projects, along with the mechanism for monitoring and evaluating their progress; and
- (c) the details of the fund allocation and expenditure incurred under PMJVK during the last five years and the current year, along with the sharing pattern between the Centre and States, the current status of projects sanctioned under PMJVK since its inception, including the number of districts and States covered and the types of works completed or in progress?

**ANSWER**

THE MINISTER OF MINORITY AFFAIRS

(SHRI KIREN RIJU)

(a) Under the Pradhan Mantri Jan Vikas Karyakram (PMJVK), areas are identified based on their minority population and development deficits. The States/UTs can propose infrastructure projects in the identified areas where the concentration of minority population is more than 25% in the catchment area of 15 KM radius.

Projects are approved on a need-based and gap-filling approach, prioritising sectors such as education, health, skill development, drinking water, sanitation and community infrastructure. Proposals are required to have clear land availability, avoid duplication with other schemes, and be technically and financially viable. All assets created under PMJVK are accessible to all communities while focusing on improving infrastructure in minority concentration areas.

(b) Under PMJVK, project proposals are identified by States/UTs based on local development gaps and submitted on the online portal after scrutiny by District and State Level Committees. The Ministry undertakes technical and financial appraisal, and final approvals are accorded by the Empowered Committee.

Project implementation is monitored through the PMJVK MIS portal, periodic field inspections, review meetings at District/State/Ministry levels, and independent third-party evaluations, along with UC-based financial oversight.

(c) The details of the fund allocation and expenditure made under PMJVK during the last five years and the current year is at **Annexure –I**.

The sharing pattern between the Centre and States is as under:

- 60(Central) 40 (State) - For all States, and for UTs with Legislature.
- 90 (Central) 10 (State) - For North Eastern States, Himalayan States (Himachal Pradesh and Uttarakhand) and Himalayan UT with legislature (Jammu and Kashmir).
- 100% Central Share-For all Union Territories without Legislature and Central Government Organisations (CGOs)
