AVAILABILITY OF FERTILIZERS AND ITS DISTRIBUTION SYSTEM IN THE COUNTRY

185: SHRI TEJVEER SINGH:

Will the **Minister of CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) the estimated demand of fertilizers and their availability in the country for the current financial year;
- (b) whether the Ministry has implemented a digital tracking system (fertilizer tracking system) for the supply and distribution of fertilizers; and
- (c) if so, the number of States which have adopted this system till date along with the details of improvements made in the distribution system as the result of the same?

(a) The information regarding requirement (demand) and availability of fertilizers viz. Urea, DAP, MOP and NPKS in the country in the current financial year i.e. in Kharif 2025 season and during the ongoing Rabi 2025-26 season as on 26.11.2025 is shown in the table given below:

- (b) & (c) The following steps are taken by the Government before every cropping season for ensuring timely and adequate availability of fertilizers across the States:
- i. Before the commencement of each cropping season, Department of Agriculture and Farmers Welfare (DA&FW), in consultation with all the State Governments, assesses the State-wise & month-wise requirement of fertilizers.
- ii. On the basis of requirement projected by DA&FW, D/o Fertilizers allocates adequate quantities of fertilizers to States by issuing monthly supply plan and continuously monitors the availability.
- iii. The movement of all major subsidized fertilizers is monitored **throughout the country** by an on-line web-based monitoring system called **integrated Fertilizer Monitoring System (iFMS).**
- iv. Regular Weekly Video Conference is conducted jointly by DA&FW and D/o Fertilizers with State Agriculture Officials and corrective actions are taken to dispatch fertilizers as indicated by the State Governments.
