#### IMMUNIZATION COVERAGE AMONG TRIBAL CHILDREN IN MAHARASHTRA AND GUJARAT

### 1883. SHRI DHANANJAY BHIMRAO MAHADIK: SHRI BABUBHAI JESANGBHAI DESAI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Government has taken steps to improve immunization coverage among tribal children aged 0-5 years in Gujarat and Maharashtra, if so, the details thereof;
- (b) the present immunization coverage among tribal children in those States, district-wise;
- (c) the special campaigns, outreach initiatives or mobile health teams deployed in tribal areas under UIP or Mission Indradhanush;
- (d) the challenges such as inaccessibility, hesitancy or shortage of health personnel and measures taken to address them;
- (e) whether Government is collaborating with NGOs and the outcomes; and
- (f) whether any audits or evaluations have been conducted in tribal areas and their findings?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SMT. ANUPRIYA PATEL)

- (a), (c) and (d) The steps taken by the Government to improve the vaccination coverage across the country including tribal children 0-5 years of age in the State of Gujarat and Maharashtra are as follows:
  - i. The Routine Immunization (RI) sessions as well as the outreach sessions are held as per the microplan in the respective States for all the eligible beneficiaries including tribal children.
  - ii. Strategic interventions like advocacy, social mobilization, inter personal communication at family and community level along with media engagement are undertaken to strengthen demand generation.
  - iii. Outreach sessions like Village Health and Nutrition Days (VHNDs) are held within community settings close to beneficiaries, to ensure equitable access to immunization services including vulnerable populations.

- iv. Mobile medical units and mobile immunization teams are also deployed in tribal areas to further extend the coverage.
- v. States/UTs have been provided with the flexibility of relaxing the norms of one ASHA per 1000 population to one ASHA per habitation in tribal /hilly and hard-to -reach areas.
- vi. Supplementary immunization activities, including catch-up campaigns are conducted in areas of low immunization coverage to vaccinate left out and drop out children.
- vii. 12 phases of Mission Indradhanush were conducted to improve the immunization coverage in the eligible beneficiaries who have missed their routine immunization doses.
- viii. Under the Pulse Polio programme, special vaccination campaigns such as National Immunization Day (NID) and Sub National Immunization Day (SNID) are conducted.
- ix. Under the PM-JANMAN (Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan), the PVTG (Particularly Vulnerable Tribal Groups) households and habitations are provided with routine immunization services by Mobile Medical Units.
- x. Swasth Nari Sashakt Parivar Abhiyan was conducted between the period 17<sup>th</sup> September 2025 to 2<sup>nd</sup> October 2025, by the Ministry of Health and Family Welfare (MoHFW) and Ministry of Women and Child Development (MoWCD) which included immunization activities for the eligible beneficiaries.
- xi. Extensive Information, Education and Communication (IEC) initiatives are carried out through service broadcasters such as Doordarshan using media celebrities, radio jingles and You tube podcasts. Village elders and Gram Pradhans, from within the community serve as influential local figures for demand generation.
- (b) The district-wise Full Immunization Coverage (FIC) in the State of Gujarat and Maharashtra for the current FY 2025-26, including tribal districts, is placed at Annexure 1 and 2 respectively.
- (e) As per the information received from the Ministry of Tribal Affairs (NGO Division), the Government is collaborating with Non-Government Organizations working for welfare of Scheduled Tribes. The details of the outcome of these collaboration is placed at Annexure 3.
- (f) National Family Health Survey (NFHS) is a third party evaluation, conducted across the country including tribal districts. The Full Immunization Coverage as per the latest NFHS 5 (2019-21) survey for the state of Maharashtra and Gujarat is 74.7% and 80.2% respectively.
