IMPLEMENTATION OF PLASTIC PARKS SCHEME

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) the total number of plastic parks approved, operational and under implementation across the country under the Plastic Parks Scheme along with the details of central assistance released to each State, so far;
- (b) whether any evaluation has been conducted to assess the scheme's impact on employment generation, MSME participation and reduction in import dependency of polymer-based products;
- (c) the progress achieved vis-à-vis the targets set in terms of infrastructure development and private investment mobilisation; and
- (d) whether Government has received any fresh proposals from States or Union Territories for setting up new plastic parks and the action taken thereon?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SMT. ANUPRIYA PATEL)

(a) Ten plastic parks have been approved by the Department under the scheme. The work in one park has been stayed by the Hon'ble National Green Tribunal, Chennai. In seven parks, the basic infrastructure works have been completed, and the plots have been allocated to the industries. Out of these seven, in four parks, the plastic units are functioning. The details of approved plastic parks under the Plastic Parks Scheme, along with the details of central assistance released, are as under:
