FLOOD RELIEF AND DAMAGE ASSESSMENT IN J&K

1995 SHRI SAJJAD AHMAD KICHLOO:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) the details of damage assessed, total amount of central assistance released so far in 2025 floods for relief, compensation and restoration in UT of J&K, giving separate figures of SDRF, NDRF and any ad-hoc central allocation with dates on which these amounts were released; and

(b) financial assistance sanctioned or distributed to number of affected families, farmers and small business units, district-wise?

(a): This Ministry does not centrally maintain the data regarding loss of life and property caused due to any calamity. However, as per information received from Union Territory of Jammu and Kashmir, 199 human lives and 11693 livestock are lost and 8404 houses and 77915 hectare crop area damaged as on 10.12.2025 due to floods/heavy rains during 2025.

In wake of notified disasters, the financial assistance to states is provided from State Disaster Response Fund (SDRF) and National Disaster Response Fund (NDRF), whereas, in case of Union Territories, the relief is provided from Union Territory Disaster Response Fund (UTDRF).

An amount of Rs. 2499.00 crore has been stated to be available as opening balance as on 1st April 2025 by the Union Territory of Jammu & Kashmir for management of relief for notified natural disasters including flood, landslides in the affected areas during 2025-26. Further, during the year 2025-26, an amount of Rs. 279.00 crore has been allocated to Union Territory of Jammu & Kashmir with respect to Disaster Response Fund (DRF) under Demand 58, out of which, an amount of Rs. 209.25 crore has been released on 29.08.2025.

In the instant case of flood/landslide in Jammu and Kashmir, an Inter-Ministerial Central Team (IMCT) was constituted on 27th August, 2025, without receipt of memorandum from the Union Territory of Jammu & Kashmir. The IMCT visited the affected areas for on-the-spot assessment of damages from 3rd-8th September 2025. Based on the report received from the IMCT, further action is taken, as per the established procedure.

Further, as per information received from Union Territory of Jammu and Kashmir, an amount of Rs. 140.50 lakh was directly transferred online in respect of 63 deaths and 29 injured persons affected due to cloudburst incident occurred in Kishtwar district on 14.08.2025, under the Prime Minister's National Relief Fund (PMNRF).

(b): As per information received from the Union Territory of Jammu & Kashmir, the district wise details of the relief assistance provided to the flood affected families, farmers etc. are enclosed at Annexure.
