TRAINEES UNDER SAMARTH SCHEME

2389. SHRI DIGVIJAYA SINGH:
SMT. RANJEET RANJAN:

Will the Minister of TEXTILES be pleased to state:

- (a) State-wise and year-wise data on the number of youth trained under Samarth since 2021 onwards, broken-down by sectors identified under the scheme;
- (b) State-wise data on the number of dalit, adivasi and women trained under the scheme;
- (c) State-wise data on the number of trainees under the scheme working in the organized sector and unorganised sector; and
- (d) whether the Ministry has taken steps to ensure that the training provided under the scheme aligns with current industry requirements, if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR TEXTILES
(SHRI PABITRA MARGHERITA)

(a) & (b): Samarth (Scheme for Capacity Building in Textiles Sector) of Ministry of Textiles provides demand driven, placement-oriented skilling programmes to supplement the efforts of the industry in creating jobs in the organized textile and related sectors, covering the entire value chain of textiles, excluding Spinning and Weaving in organized sector, on pan India basis. Under the Scheme, A total of 5.26 lakh beneficiaries which include for, 4,67,596 women, 1,44,708 SCs and 68,621 STs beneficiaries have been trained (pass) since (FY 2021-22) till 11.12.2025. State/UTs-wise, Sector-wise and year-wise number of beneficiaries passed which include women, SCs, STs as on 11.12.2025 under Samarth Scheme are given in **Annexure I**.

(c): State/UTs-wise number of beneficiaries placed under Samarth scheme (which include both organized and traditional sector) (as on 11.12.2025) is given in **Annexure II**.

(d): The Ministry of Textiles has taken several steps to ensure that the training under Samarth scheme is aligned with the current requirements of the textile sector.

- i. All training courses are aligned with National Skill Qualifications Framework (NSQF) and these courses are periodically reviewed and updated every 3 years in consultation with industry stakeholders.
- ii. Periodic reviews and feedback are obtained from industry partners and stakeholders on the content and effectiveness of training modules, ensuring their relevance and continuous improvement.
