**Fisherman benefitted from PMMSY**

**385 Shri Jose K. Mani:**

Will the Minister of *Fisheries, Animal Husbandry and Dairying* be pleased to state:

- (a) whether the Government has data regarding the number of fishermen who have benefited from the Pradhan Mantri Matsya Sampada Yojana (PMMSY) over the last five years;
- (b) if so, State-wise details thereof; and
- (c) details of funds allocated and utilised under PMMSY over the last five years?

**ANSWER**

(a) and (b): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying under Pradhan Mantri Matsya Sampada Yojana (PMMSY) during the last five financial years (2020-21 to 2024-25) has accorded approvals to the proposals of 35 States/Union Territories and other Implementing Agencies amounting to Rs. 21274.16 crore with central share of Rs.9189.79 crore. As per the report submitted by States/Union Territories on PMMSY-MIS portal, 338331 fishers & fish farmers are directly benefitted under various activities approved under the PMMSY. In addition, 7,71,181 beneficiaries are covered under livelihood & nutritional support, 33,72,072 are covered annually under insurance. The State/UT-wise details of beneficiaries under PMMSY during the last five financial years (2020-21 to 2024-25) under PMMSY are furnished at Annexure-I.
