**SVAMITVA IMPLEMENTATION IN GUJARAT**

420. SHRI NARHARI AMIN:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the number of villages surveyed, property cards issued and rural households benefitted in Gujarat under SVAMITVA Scheme, district-wise;
- (b) whether drone mapping has been completed for all notified villages in Gujarat and the status of integration with State land records/digital platforms; and
- (c) the number of property-linked loans or credit facilities availed by Gujarat households due to SVAMITVA records and examples of such utilisation?

**ANSWER**

- (a) In Gujarat, drone survey has been completed in 14,670 villages, about 15.7 lakh property cards have been issued in 9,680 villages. It may be noted that the Ministry does not maintain household-wise data of beneficiaries. District wise status is annexed as **Annexure I**.
- (b) In Gujarat drone survey has been completed in 14,670 villages out of 15,025 notified inhabited villages. In Gujarat SVAMITVA maps prepared are integrated with various State land records and digital platforms. For ground-truthing and verification, SVAMITVA data in Gujarat is integrated with the *Gram Suvidha Portal* of the State for fetching owner details. The inquiry process is completed on the portal developed by the State and final property cards are generated. The final property cards generated under the Scheme are integrated with the *City Survey Information System* of the State for their maintenance and regular updation.
- (c) In Gujarat as per information shared by State, 43 loans worth Rs 3.73 crore have been availed against SVAMITVA property cards. The Ministry of Panchayati Raj does not maintain individual beneficiary wise data. The purpose of utilization can be minor repairs, business improvement etc.
