STATUS OF PM-JANMAN AND PVTG DEVELOPMENT

468 SHRI SUJEET KUMAR: SHRI NARHARI AMIN:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the status of saturation achievement under Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) interventions as of November 15, 2025 deadline;
- (b) how Ministry is utilising Gram Sabha certification to validate completion of PM-JANMAN infrastructure projects;
- (c) whether entire financial outlay of ₹24,104 crore for PM-JANMAN has been allocated to nine line Ministries;
- (d) specific mechanisms being established to monitor the maintenance of solar power systems and Multi-Purpose Centers (MPCs) in Particularly Vulnerable Tribal Groups (PVTG) areas; and
- (e) how Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DA-JGUA) is ensuring convergence with PM-JANMAN objectives?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

(a) to (c): Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) is targeted at socio-economic development of 75 PVTGs communities residing in 18 states and one UT. The details of targets and achievements under the abhiyan since its inception is given in Annexure-I. PM JANMAN has total budgetary outlay of Rs.24,104 Cr (Central share: ₹15336 Cr and State share: ₹8768 Cr) which is assigned to respective line Ministries against the identified interventions. However, the actual

yearly requirements from the line Ministries are subject to verified gaps as per schematic norms, demands from State Governments/Implementing agencies, financial and physical progress and applicable financial rules / instructions.

The Ministry has been urging the State Governments and line Ministries the need to achieve saturation of interventions (for eligible beneficiaries) under the Abhiyan and, wherever required, to obtain Gram Sabha certification regarding saturation of specific services in the concerned villages.

(d): As informed by Ministry of New and Renewable Energy, implementing the New Solar Power Scheme (for Tribal and PVTG Habitations/Villages) under PM JANMAN and DA JGUA, under the scheme, the Central Financial Assistance (CFA) covers the entire cost of the system applicable taxes, transportation, installation, onsite comprehensive maintenance services for 5 years. Further, the scheme also mandates the provision of Remote Monitoring System (RMS) to ensure proper functioning and maintenance.

For operationalization of multi-purpose centres, Ministry of Tribal Affairs has issued a detailed SOP to State Governments and other stakeholders. These MPCs are to be operated under the District administration in coordination with concerned line Departments.

(e): By adopting convergence approach of PM JANMAN, Dharti Aaba Janjatiya Gram Utkarsh Abhiyan comprises of 25 interventions implemented by 17 line Ministries and aims to saturate infrastructural gaps in 63,843 villages, improve access to health, education, Anganwadi facilities and providing livelihood opportunities benefiting more than 5 crore tribals in 549 districts and 2,911 blocks in 30 States/UTs.
