TOURISM PROJECTS IN KOLHAPUR

613 SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has identified Kolhapur as a potential heritage and spiritual tourism circuit under the Swadesh Darshan or PRASHAD scheme;
- (b) the details of funds sanctioned and utilized for the development of Mahalaxmi Temple, Rankala Lake and Panhala Fort;
- (c) whether any new tourism infrastructure projects are planned for the district; and
- (d) if so, the timelines proposed for their implementation?

ANSWER

THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (d): Development of tourist destinations and products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry complements the efforts of States/UTs by developing tourism infrastructure through various schemes and initiatives in consultation with the State Governments/ UT Administrations.

Receiving proposals from the State Governments/UT Administrations for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions and availability of funds.

The Ministry of Tourism has not identified/sanctioned Kolhapur as a potential heritage and spiritual tourism circuit under the PRASHAD or Swadesh Darshan scheme.

Further, no project have been sanctioned at Mahalaxmi Temple, Rankala Lake or Panhala Fort under the ongoing schemes. However, the Ministry of Tourism has sanctioned various projects in Maharashtra, the details of which are given in the Annexure.
