### ROADMAP TO PROMOTE TOURISM INDUSTRY IN SOUTH INDIA

### 620 SHRI I.S. INBADURAI:

Will the Minister of **TOURISM** be pleased to state:

- (a) the number of tourists who visited the country during the last twelve months;
- (b) the number of tourists who visited the country since 2021, after the pandemic;
- (c) whether the country aims to achieve 100 million tourist arrivals in future and if so, the details thereof;
- (d) whether Government has prepared any roadmap to promote tourism, including specific plans for southern States, specifically the proposal to set up and promote an international tourism park at Radhapuram, Tirunelveli along with the details of fund allocation; and
- (e) whether Government proposes to develop Kodavilai at Tirunelveli for "Blue Beach" tourism purposes and if so, the funds allocated therefor?

(c) to (e): The Ministry of Tourism has taken several steps and initiatives to boost tourist arrivals and promote the tourism sector in the country. The details are as follows:

The Ministry of Tourism under the schemes of 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' provides financial assistance to State Governments/ Union Territory Administrations/ Central Agencies for the development of tourism-related infrastructure and facilities at various tourism destinations in the country, including Tamil Nadu.

The Ministry of Tourism has now revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD 2.0) with the objective to develop sustainable and responsible tourism destinations, following a destination & tourism-centric approach.

Additionally, the Ministry of Tourism has formulated "Challenge Based Destination Development (CBDD)" as a sub-scheme under SD2.0 aiming for holistic development of destination to enhance tourist experience.
