USER DEVELOPMENT FEE CHARGES

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) whether Airports Economic Regulatory Authority of India (AERA) determines aeronautical charges including User Development Fee (UDF);
- (b) if so, the amount of UDF inclusive of GST charged at Mangalore, Bangalore and Hubli airports embarking domestic passengers as on 30th June, 2025;
- (c) the amount of UDF inclusive of GST charged at Mangalore, Bangalore and Hubli airports for disembarking domestic passengers as on 30th June, 2025; and
- (d) the amount of UDF fixed by the Airports Economic Regulatory Authority (AERA) for all airports, exclusive of GST?

ANSWER

(a): Yes. The Airports Economic Regulatory Authority (AERA) of India, in accordance with the provisions of Section 13 of AERA Act, 2008, is mandated to determine tariff for the aeronautical services and other charges, including User Development Fee (UDF) at Major Airports.

(b) & (c): As on 30.06.2025, UDF at Mangalore Airport is Rs. 735 for embarking domestic passenger and Rs. 315 for disembarking domestic passenger. At Bangalore Airport, UDF for embarking domestic passenger is Rs. 550, while no UDF is levied on disembarking domestic passenger. At Hubli airport, UDF for embarking domestic passenger is Rs. 656, while no UDF is levied on disembarking domestic passenger. GST, at the rates notified by the Ministry of Finance, is applicable on the above UDF rates.

(d): The amount of UDF (excluding GST) as determined by AERA for all Major Airports for the FY 2025-26 is attached as Annexure.
