DEVELOPMENT OF GREEN SPACES AND PARKS UNDER AMRUT

857. MS. SWATI MALIWAL:

Will the Minister of **HOUSING AND URBAN AFFAIRS** be pleased to state:

- (a) total funds approved, released and utilised under the “Green Spaces and Parks” component of the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) and (AMRUT) 2.0 schemes, State/UT-wise since inception;
- (b) the number and area of parks developed or upgraded under these schemes, State/UT- wise;
- (c) the number of proposals submitted by the State Governments of Punjab and Delhi, including the number of projects approved, funds sanctioned and utilised and current implementation status details thereof; and
- (d) whether any projects in the State of Punjab or NCT of Delhi are facing delays and if so, the reasons therefor?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS
(SHRI TOKHAN SAHU)**

(a)& (b): Under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) and AMRUT 2.0, States/Union Territories (UTs) are empowered to select, appraise, prioritise and implement the projects within the broad framework of respective Mission guidelines. Under AMRUT, State/UTs have taken up 2,529 projects worth ₹ 1,606.31 crore for development of parks and green spaces. Under AMRUT 2.0, State/UTs have taken up 1,669 projects worth ₹1,089.31 crore have been approved under parks and green spaces sector. State/UT-wise details of approved projects are given in Annexure – I. Under the Mission, Central funds for projects are released to the States/ Union Territories (UTs) and not sector/ project-wise.

State-wise details of park projects completed and area of parks developed so far are given in Annexure – II.

(c) &(d) : The State of Punjab has taken up 43 park projects worth ₹14.09 crore under AMRUT. As informed by the State, 35 projects worth ₹11.39 crore have been completed and another 5 projects are 95% completed. In 3 projects, contractor abandoned the work and the agreement has been cancelled. Under AMRUT 2.0, 25 park projects worth ₹38.27 crore as submitted by the State, have been approved. As informed by the State, tenders have been issued for 17 projects of which 6 projects have been awarded, Detailed Project Report (DPR) have been approved for 2 projects and remaining 6 projects are at DPR stage. The State has informed that there was delay in 3 projects due to land demarcation, and contractor related issues.

The UT of Delhi has taken up 7 park projects worth ₹14.96 crore under AMRUT, all of which have been completed. Under AMRUT 2.0, 9 park projects worth ₹24.31 crore as submitted by the UT, have been approved. As reported by the UT, 02 projects have been completed, tenders have been awarded for 5 projects and 2 projects are at DPR stage. The UT has informed that the delay was mainly due to the absence of Municipal Corporation of Delhi (MCD) Standing Committee, whose approval is required for projects costing ₹5 crore and above. The Committee has been constituted.
