FUND RELEASED UNDER FMBAP

885. SHRI SAMIRUL ISLAM:

Will the Minister of **Jal Shakti** be pleased to state:

- (a) whether the Central Government has any data regarding damage caused by floods to crops, land and life in the State of West Bengal;
- (b) if so, the details thereof for the last five years, year-wise;
- (c) is it a fact that as of December, 2023 no funds have been provided by the Central Government for the execution of Ghatal Master Plan; and
- (d) the details of funds released under Flood Management and Border Areas Programme (FMBAP) since its inception, State-wise and year-wise?

ANSWER

(a) to (c) Crop, land and life damage data of State due to floods is not maintained centrally. Flood management and anti-erosion schemes are formulated and implemented by concerned State Governments as per their priority. The Union Government supplements the efforts of the States by providing technical guidance and also promotional financial assistance for management of floods in critical areas. Ghatal Master Plan has not been included under Flood Management Programme (FMP) component of Flood Management and Border Area Programme (FMBAP) for not fulfilling the criteria for inclusion, namely, 'Projects from only those States may be included who have implemented Flood Plain Zoning (FPZ) either through a legislation or through an appropriate Executive Order'.

(d) The State-wise details of funds released under Flood Management and Border Areas Programme (FMBAP) is given at **Annexure**.
