IMPLEMENTATION OF PM-VISHWAKARMA SCHEME

915. MS. INDU BALA GOSWAMI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) number of people who have applied under PM-Vishwakarma Scheme, so far, State-wise details including the State of Himachal Pradesh;
- (b) number of people selected under the said scheme so far; and
- (c) the amount of money Government has decided to spend under the said scheme?

ANSWER

- (a): PM Vishwakarma scheme was launched on 17.09.2023, to provide end-to-end holistic support to artisans and craftspeople of 18 traditional trades who work with their hands and tools. The State-wise number of artisans who have applied under the scheme, including the state of Himachal Pradesh is at **Annexure –I**.
- (b): Against the target of coverage of 30 lakh beneficiaries; 30 lakh artisans/craftspeople have been selected/registered under the scheme.
- (c): Under PM Vishwakarma scheme, Government has earmarked a budget of Rs. 13,000 crore for a period of five years (FY 2023-24 to 2027-28).
