**PERFORMANCE OF NAI UDAAN AND NAYA SAVERA SCHEMES**

**927. SMT. JEBI MATHER HISHAM:**

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) details of number of applicants, number of persons enrolled and number of persons trained under the erstwhile Nai Udaan and Naya Savera schemes since their inception, year-wise, State-wise;
- (b) number of minority candidates supported under these schemes year-wise since their inception who subsequently cleared the final examinations of UPSC, SSC, State Public Service Commissions and other qualifying or recruitment examinations, along with examination-wise details; and
- (c) details of empanelled Project Implementing Agencies engaged for implementing the schemes, including any cancellation, withdrawal, discontinuation of empanelment, along with the reasons therefor, the specific projects for which they were empanelled, year-wise?

**ANSWER**

THE MINISTER OF MINORITY AFFAIRS

(a) to (c) The Ministry of Minority Affairs implemented 'Nai Udaan' Scheme to provide financial support to the minority candidates who qualify in the preliminary examinations conducted by Union Public Service Commission (UPSC), Staff Selection Commission (SSC), and State Public Service Commissions (SPSCs).

Further, Ministry of Minority Affairs also implemented a scheme namely "Free Coaching and Allied Scheme for the candidates/students belonging to minority communities/ Naya Savera" under which Free Coaching was provided to assist students/candidates belonging to the notified minority communities by way of special coaching for qualifying examinations for admission in technical/professional courses and competitive examination for recruitment to Group 'A, 'B' & 'C' services and other equivalent posts under the Central and State Governments including public sector undertakings, banks, railways etc.

The 'Nai Udaan' and 'Naya Savera' Schemes have been discontinued w.e.f. Financial Year 2022-23. The State/UT wise number of candidates who have benefitted under the 'Nai Udaan' scheme is attached at Annexure-I. Further, the State/UT wise number of beneficiaries benefitted/trained under the 'Naya Savera' scheme is attached at Annexure-II.

Under the Nai Udaan Scheme, financial assistance was provided only to those students who have cleared the preliminary examinations of UPSC, SSC, State Public Service Commissions and other qualifying or recruitment examinations. However, details of candidates who have finally cleared the exam were not maintained under the said scheme.

Under 'Nai Udaan' Scheme, the financial assistance were directly provided to successful candidates. Further, under 'Naya Savera' Scheme, details of Project Implementing Agencies engaged for implementing the schemes are available on the Ministry's website i.e. [www.minorityaffairs.gov.in](http://www.minorityaffairs.gov.in).
