PADHO PARDESH SCHEME

929. SMT. RAJATHI:

Will the Minister of Minority Affairs be pleased to state:

- (a) whether Padho Pardesh interest subsidy scheme for minority students pursuing higher education abroad has been discontinued from 2022-23, and if so, the reasons therefor;
- (b) the number of beneficiaries covered under the scheme since inception, State-wise;
- (c) whether Government has reviewed the impact of discontinuation on access to international education for economically weaker minority students;
- (d) whether Government proposes to introduce an alternative scheme to support minority students seeking higher education abroad; and
- (e) the timeline for reviving or replacing the scheme to ensure continued educational opportunities for minority youth?

ANSWER

THE MINISTER OF MINORITY AFFAIRS

(SHRI KIREN RIJIJU)

(a) to (e): Padho Pardesh Scheme was implemented by the Ministry of Minority Affairs, Government of India for providing subsidy to minority community students on the interest payable on the educational loan for overseas studies.

The National Minorities Development & Finance Corporation (NMDFC), a PSU under Ministry of Minority Affairs, also provides educational loan for education abroad, at lower rate of interest, exclusively to students belonging to minority communities. It was also observed that benefits of interest subsidy that get accrued to the beneficiaries under the Padho Pardesh scheme were limited and also that there was an apparent overlap with other similar schemes being implemented by other Ministries which are applicable to eligible minority community students as well. In view of the aforesaid overlap, limited benefits and ease of availing education loans on lower rate of interest, the Padho Pardesh Scheme has been discontinued from 2022-23.
