STATUS OF SUPPLY OF FERTILIZER AND JAN AUSHADHI KENDRAS IN JHARKHAND

984: SHRI PRADIP KUMAR VARMA:

Will the **Minister of CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) the number of jan aushadhi kendras operational in Jharkhand and the number of new centres which have been approved till November 2025;
- (b) whether it is a fact that the supply of DAP and urea to farmers in Jharkhand is being ensured on time; and
- (c) the steps taken for digitisation of the fertilizer distribution system in the State?

ANSWER

(a) Under Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP), till 30.11.2025, 164 Jan Aushadhi Kendras (JAKs) have been opened in the State of Jharkhand, of which 27 JAKs have been opened from 01.04.2025 to 30.11.2025.

(b) & (c) The availability of Urea and DAP has remained adequate in the State of Jharkhand during the ongoing Rabi 2025-26 season. The information regarding requirement, availability, sales and closing stock of the these fertilizers in the State of Jharkhand during the ongoing Rabi 2025-26 season as on 04.12.2025 is as under:

Further, the following steps are taken by the Government every season for ensuring timely and adequate availability of fertilizers in the country, including the State of Jharkhand:

- (i) Before the commencement of each cropping season, Department of Agriculture and Farmers Welfare (DA&FW), in consultation with all the State Governments, assesses the State-wise & month-wise requirement of fertilizers.
- (ii) On the basis of requirement projected by DA&FW, D/o Fertilizers allocates adequate quantities of fertilizers to States by issuing monthly supply plan and continuously monitors the availability.
- (iii) **The movement of all major subsidized fertilizers is monitored throughout the country by an on-line web-based monitoring system called integrated Fertilizer Monitoring System (iFMS).**
- (iv) The State Governments are regularly advised to coordinate with manufacturers and importers for streamlining the supplies through timely placement of indents.
- (v) Regular coordination meetings are held with Ministry of Railways for giving sufficient rakes, priority to fertilizers and for timely evacuation of rakes for States.
- (vi) The distribution of fertilizers within the State at district level is done by the concerned State government.
