- (a) Yes, the 15th Finance Commission (FC) had recommended a Health Sector Grant (HSG) for local bodies amounting to a total of Rs. 70,051 crore to various States including the State of Telangana for its award period 2021-26.
- (b) The details of State-wise amount recommended and released (up to 28.01.2026) as Health Sector Grant to various States including the State of Telangana during the period 2021-26 are given in Annexure-I.
