INDIA'S TB ELIMINATION GOAL

420 SHRI MALLIKARJUN KHARGE:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Government had targeted to achieve fewer than one TB case/million population by 2025, if so, current national and State-wise status against this target;
- (b) whether India recorded 187 TB cases/lakh population in 2024, if so, reasons for shortfall in achieving the target;
- (c) the details of funds sanctioned, allotted, released and utilised, year-wise and State-wise since inception, under National Tuberculosis Elimination Programme (NTEP), Pradhan Mantri TB Mukt Bharat Abhiyaan (PMTB MBA) and Ni-kshay Poshan Yojana (NPY);
- (d) the corrective actions taken to address reasons for shortfall, with timelines and responsible agencies; and
- (e) whether Government has revised timelines or interim milestones for TB elimination and if so, the revised targets, State-wise?

**ANSWER

(a) to (e) To achieve sustainable goals target of 2030, the Government has implemented TB Mukt Bharat Abhiyan (National TB Elimination Programme, under the aegis of National Health Mission (NHM) in all States/UTs of the country. As per the World Health Organization's Global TB Report 2025, the annual TB incidence rate has declined by 21% from 237 cases per lakh population in 2015 to 187 cases per lakh population in 2024. The State-wise details of TB cases notified in 2025, as reported by the State/UTs in Ni-kshay portal is placed as **Annexure-I**.

Under the programme, the key steps taken to sustain momentum and accelerate response towards TB elimination, are as under:

- Targeted interventions in high TB burden areas through State and District Specific Strategic plans.
- Provision of free drugs and diagnostics to TB patients.
- Intensified TB case-finding among vulnerable populations through mobile diagnostic units for reaching out to remote and rural areas.
- Decentralization of TB screening and treatment services to the Ayushman Arogya Mandir (AAM).

- Private sector engagement with incentives for notification & management of TB cases.
- Scaling up of molecular diagnostic laboratories in all blocks to facilitate early TB diagnosis.
- Ni-kshay Poshan Yojana of Rs 1,000 per month per patient as nutritional support for the entire duration of treatment.
- Intensified Information, Education & Communication (IEC) interventions to reduce stigma, enhance community awareness and improve health seeking behaviour.
- Provision of TB Preventive Treatment to contacts of TB patients and vulnerable population.
- Tracking of notified TB cases through Ni-kshay portal.
- Provision of additional nutritional support to TB patients and household contacts under Ni-kshay Mitra initiative.

Further to address TB among the vulnerable population, Government has implemented TB Mukt Bharat Abhiyan across the country with the key strategies include identification of vulnerable population including asymptomatic, screening by Chest X-ray for early detection, upfront Nucleic Acid Amplification Test (NAAT) for all presumptive TB cases, timely treatment initiation & completion, differentiated TB care for managing high-risk TB cases, nutrition support and preventive treatment to eligible vulnerable population.

Community engagement is ensured through the comprehensive primary care package of services provided by Ayushman Arogya Mandir (AAM). Intensive Information, Education and Communication (IEC) activities are conducted to educate the public and raise awareness about symptoms, TB prevention and the importance of timely treatment for TB. Jan Bhagidari activities are implemented with involvement of Schools, Panchayati Raj Institutions, Self Help Groups, Anganwadis, local Non-Government Organisations and Civil Society Organizations.

The cash grants for implementation of TB Mukt Bharat Abhiyan, is provided as part of RCH Flexipool which includes TB. The details of kind grants allotted, released and expenditure made, year-wise and State-wise since 2022-23, under National Tuberculosis Elimination Programme (NTEP), and Ni-kshay Poshan Yojana (NPY) since 2018 are placed as **Annexure-II (part A and part B)** and **Annexure-III** respectively.
