PUBLIC RESPONSE TO ROOFTOP SOLAR INSTALLATION UNDER PMSGMBY

2700. SHRI P. P. SUNEER

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) what is the response of the States and the people to the rooftop solar installations under the PM Surya Ghar: Muft Bijlee Yojana (PMSGMBY); and
(b) the details of the number of solar installations made so far, households covered, installation capacity and subsidy released, State-wise?

ANSWER

(a) & (b) The PM Surya Ghar: Muft Bijli Yojana (PMSG: MBY) is a demand-driven scheme wherein all residential consumers in the country, having a grid-connected electricity connection with the local DISCOM, can avail the benefits of the scheme, for installation of RTS systems by applying on the National Portal (www.pmsuryaghar.gov.in) of the scheme.

Under the scheme, since its launch in February 2024, a total of 77,65,047 applications have been received, 41,94,051 rooftop solar (RTS) systems with a cumulative installed capacity of 14,894.95 MW have been installed, benefitting 50,43,893 households and an amount of Rs. 28,390.50 crore has been released as Central Financial Assistance (CFA) across the country, as on 05.08.2026. The state/UT-wise details are placed at **Annexure**.
