(i)Need to set up a panel to study the feasibility of taking water of Himalayan rivers to central and southern parts of India

SHRI N.S.V. CHITTHAN (DINDIGUL): Our country has a very grave water problem. There is alarming scarcity of water across the country. To bring the surplus flood water of Himalayan range down south through canals is definitely an alternative to river linking project. To harvest water from Himalayan rivers at higher altitude and bring them to a meeting point at Nahan in Himachal Pradesh (Alt 820 m AMSL) and run them through open canals over embankments wherever needed to maintain the height with slope of 1:20000 so that it crosses over easily the central and Deccan Plateau by gravitation which is the only feasible solution. It is not a river linking proposal. But getting water from the Himalayan rivers at an altitude before reach the plains and bringing them through man made open canals.

As a valuable corollary benefit the flood control, navigation, water supply, fisheries, pollution control, recreation facilities, employment generation, infrastructure and socio-economic developments would change the face of the country's economy.

I urge upon the Government to set up a panel urgently to study and submit a feasible report to proceed further.

(ii) Need to release arrears of incentive payable to employees of Bank Note Press, Dewas, Madhya Pradesh

श्री सज्जन वर्मा (देवास): बैंक नोट प्रेस देवास के कर्मचारियों को छठें वेतनमान का पूर्ण लाभ अब तक नहीं दिया गया है। सितम्बर 2008, मिन्ट एवं प्रेसेज की 9 इकाइयों को कारपोरेशन के अधीन करके एरियर का भुगतान तो कर दिया गया, परन्तु जनवरी 2006 से अगस्त 2008 तक की इन्सेन्टिव राशि का भुगतान नहीं किया गया। चूंकि उक्त समयाविध में बीएनपी देवास के कर्मचारी वित्त मंत्रालय के अधीन थे तथा उक्त अविध में सेवानिवृत्ति एवं अन्य लाभ वित्त मंत्रालय द्वारा दिये गये थे।

फरवरी, 2010 से एसपीएमसीआईएल में बीएनपी की यूनियनों के साथ 9 इकाइयों में समान व्यवस्था लागू करने के लिए किये गये समझौते में 35 प्रतिशत सीलिंग सिंहत नई इन्सेन्टिव योजना लागू की गई, इससे पहले अलग-अलग इन्सेन्टिव योजनायें थी।

अतः मैं केन्द्र सरकार और वित्त मंत्री जी से अनुरोध करता हूं कि बीएनपी देवास के कर्मचारियों को उक्त अवधि का बकाया इन्सेन्टिव एरिया की राशि का भुगतान शीघ्र कराने के आदेश जारी करें।

(iii) Need to set up additional model schools in Barmer and Jaisalmer districts of Rajasthan

श्री हरीश चौधरी (बाड़मेर): मेरे संसदीय क्षेत्र के बाड़मेर जैसलमेर जिलों की विशेष भौगोलिक स्थितियों को देखते हुए अतिरिक्त मॉडल स्कूल स्वीकृत किये जाने की आवश्यकता है। इन जिलों का क्षेत्रफल क्रमशः 28393 एवं 39313 वर्ग कि.मी.. है। वर्ष 2011 की जनसंख्या के अनुसार बाड़मेर जिले की जनसंख्या 2604453 है। इस क्षेत्र में सर्व शिक्षा एवं अन्य शैक्षणिक गतिविधियों के संचालित होते हुए भी साक्षरता दर 57.49 प्रतिशत है उसमें भी महिला साक्षरता दल मात्र 41.03 प्रतिशत है। बाड़मेर जिले में आठ पंचायत समिति क्षेत्र हैं। मेरी जानकारी के अनुसार जिले के लिए मात्र छः मॉडल स्कूल खोला जाना प्रस्तावित है।

मेरा सरकार से अनुरोध है कि इस सीमावर्ती क्षेत्र की भौगोलिक स्थितियां, जनसंख्या एवं कम साक्षरता दर जैसी विशेष परिस्थितियों को देखते हुए ब्लॉक मुख्यालय के अतिरिक्त मॉडल विद्यालय खोले जाने की स्वीकृति प्रदान की जाए।

(iv)Need to take necessary action to fix the inter-se-seniority of Officers in Airports Authority of India

SHRI MANICKA TAGORE (VIRUDHUNAGAR): Airports Authority of India (AAI) is executing and functioning in different Airports & Airports projects all over India and having more than 1100 officers memberships in Airports Authority of India Officers Association (AAIOA). Earlier, i.e. before 1995, there were two different organizations namely National Airports Authority and International Airports Authority of India. Both were merged into one as Airports Authority of India (AAI) on 1.4.1995. To fix the seniority among the staff of merged organization, a committee headed by Justice Jain was appointed on 1.4.1995 but the recommendations of the Committee have not been implemented so far.

Further, various committees headed by Shri P. Rajendran, Shri P.S. Nair and Shri M. Krishnamurthy submitted their reports but no action has been taken by the Government so far. Further, number of meetings also were held among the officers and management even with the then Hon'ble Minister Civil Aviation, but no action has been taken to solve the problems for the last 16 years.

Hence, I urge upon the Union Government to take necessary action to implement the inter-se seniority in accordance with AAI Act, 1994 at the earliest.

(v) Need to provide stoppage of Porbander-Kochuveli Express, Dadar-Tirunelvelli Express and Hapa-Madgaon Express at railway stations at Kankavli, Kudal and Sawantwadi road in Ratnagiri-Sindhudurg Parliamentary Constituency, Maharashtra

'SHRI NILESH NARAYAN RANE (RATNAGIRI-SINDHUDURG): I would like to draw the attention of the Hon'ble Minister of Railways towards the plight of the people of Maharashtra, Konkan, especially the people of Ratnagiri – Sindhudurg due to lack of stoppages in the high density rail traffic routes between Ratnagiri and Sindhudurg section of the Konkan Railways. All the trains in the Konkan Railway plying to/from Kerala, Karnataka and Goa pass through Ratnagiri – Sindhudurg, but no adequate stoppage are there in this section to cater to the needs of burgeon rail commuters.

A weekly train namely, Porbander – Kochuvelli Express, which was announced by Western railway to commence its services shortly does not have halt between Ratnagiri and Sindhudurg section. Besides, two proposed new trains in this year Railway Budget, namely Dadar – Tirunelvelli Express and Hapa – Madgaon Express on Konkan Railway route surprisingly have no halts between the Ratnagiri and Sindhudurg section of the Maharashtra Konkan region. This has caused a huge disappointment to the people of Ratnagiri-Sindhudurg, for whom Konkan Railway is literally their lifeline.

Ratnagiri – Sindhudurg is a region of exquisite tourists interests that attracts domestic as well as foreign tourists in large number. Besides, the people of this region have to commute to Mumbai and other places on that route. There is an imperative need to enhance existing frequencies, additional provisioning of reservation quota and increase in number of stoppage of trains plying in this route can hardly be over-emphasized.

I urge Hon'ble Railway Minister to kindly ensure addition of stops between Ratnagiri and Sawantwadi stations for the above mentioned three trains at

Kankavli, Kudal and Sawantwadi Road in the larger public interest as also to harness the untapped tourism potential.

(vi) Need to provide adequate quantity of LPG cylinders and permit new LPG distribution agencies in Faizabad Parliamentary Constituency, Uttar Pradesh

डॉ. निर्मल खत्री (फ्रेंज़ाबाद): मैं पैट्रोलियम मंत्रालय का ध्यान घरेलू कुकिंग गैस (एलपीजी) की कमी की तरफ आकृष्ट कराना चाहता हूं। मेरे लोक सभा क्षेत्र अंतर्गत जनपद फैजाबाद व जनपद बाराबंकी, दियाबाद विधानसभा क्षेत्र के अंतर्गत घरेलू गैस के वितरण व उपलबधता की कमी से आम आदमी परेशान है। सुबह से लम्बी-लम्बी लाइनों में लगना व फिर भी गैस न मिलना पिछले एक वर्ष से यही चल रहा है। सरकार इस कमी को दूर करने के लिए संबंधित कंपनियों को आदेश करे कि वे गैस सिलेंडर की पर्याप्त आपूर्ति करे साथ ही बढ़े गैस उपभोक्ताओं की संख्या के आधार पर गैस सिलेंडर का कोटा भी बढ़ाया जाये।

इस सिलिसले में मेरा यह भी अनुरोध है कि मेरे लोक सभा क्षेत्र में विभिन्न स्थानों पर नये वितरक (एजेंसी) खोले जाने की जरूरत है, जो कि इस प्रकार है। जनपद बाराबंकी में रामसनेही घाट तहसील मुख्यालय (भिटिरया) टाउन एरिया दियाबाद क्षेत्र, टिकैतनगर टाउन एरिया क्षेत्र और जनपद फैजाबाद में नगरपालिका रूदौली, क्षेत्र टाउन एरिया भदरसा क्षेत्र, टाउन एरिया बीकापुर क्षेत्र, सोहावल तहसील मुख्यालय सुचितागंज बाजार, मिल्कीपुर तहसील मुख्यालय इनायत नगर, कुमारगंज बाजार (ब्लाक अमानीगंज) पूराबाजार (ब्लाक-पूरा), नगरपालिका अयोध्या क्षेत्र, शहर फैजाबाद क्षेत्र। शीघ्रातिशीघ्र आवश्यक कार्यवाही उपरोक्त संदर्भ में की जाये।

(vii)Need to start the fruit and vegetable processing unit in village Jahan Khelan in Hoshiarpur district, Punjab

SHRIMATI SANTOSH CHOWDHARY (HOSHIARPUR): My Parliamentary Constituency Hoshiarpur (Punjab) is famous for citrus fruit Kinnoo and for potatoes. Punjab Government established Multi-processing unit for processing of fruits and vegetables in village Jahan Khelan in Hoshiarpur to solve the marketing problem of the farmers. The total investment in this unit is round about 38 crores. But, this unit is not functioning for the reasons best known to concerned department. Punjab Government is well aware about the pathetic conditions of the farmers of Hoshiarpur but taking no interest to run the plant. I humbly request to Hon'ble Minister for Agriculture to direct the State Government to start processing unit at Jahan Khela district Hoshiarpur, Punjab so that the farmers from my backward district do not suffer.

(viii) Need to take effective steps to prevent child marriages in the country

SHRI CHARLES DIAS (NOMINATED): The prevalence of underweight children in India is among the highest in the world, with dire consequences for mobility, mortality, productivity and economic growth. The UN estimates that 2.1 million Indian children die before reaching the age of 5 every year – four every minute-mostly from preventable illness such as diarrhoea, typhoid, malaria, measles and pneumonia. Child malnutrition is responsible for 22% of India's burden of disease. One of the major reason for unhealthy children in India is that girls are forced to get married before they attain eighteen years of age. The underaged mothers mostly belong to socially and economically backward classes. They are denied basic education and forced to bear children, who are naturally unhealthy.

The girls who are forced to get married at young age from economically weaker sections and bearing children without getting proper medical care. These unhealthy pregnant girls naturally give birth to children who are weak and ill-fed. As there is no proper guidance and control and even the law cannot be enforced to remote villages where highhandedness of men usually make the law. This has resulted in creating a generation of undernourished children with deformities. The Government has to study the seriousness of the problem and try to prevent marriage of girls before eighteen years. Urgent attention of the Government is warranted to take effective measurers to prevent girls getting married before eighteen. Let us plan the future of our people, by carefully providing the underprivileged children with planned food, so that India can proudly witness the advancement of its people in the years to come.

कुमारी सरोज पाण्डेय (दुर्ग): छत्तीसगढ़ राज्य में रायपुर और दुर्ग दो महतवपूर्ण शहर हैं जो आसपास स्थित हैं और दोनों के बीच की दूरी लगभग 36 कि.मी. है, रायपुर राज्य की राजधानी है और दुर्ग एक बड़ा शैक्षणिक और औद्योगिक केन्द्र है इस वजह दोनों शहरों के बीच भारी आवाजाही हमेशा बनी रहती है। इसके अलावा राज्य गठन के पश्चात दोनों शहरों के आकार में भी वृद्धि हुई है तथा दोनों शहर लगभग आपस में जुड़ गए हैं। इन दोनों शहरों के आकार में भी वृद्धि हुई है तथा दोनों शहर लगभग आपस में जुड़ गए हैं। इन दोनों शहरों को जोड़नें वाली एकमात्र सड़क राष्ट्रीय राजमार्ग क्रमांक 6 है जोकि एक सबसे व्यस्ततम राजमार्ग है और आज की परिस्थिति में यह राजमार्ग इस सड़क से गुजरने वाले यातायात के लिए नाकाफी सिद्ध हो रहा है। इस सड़क से लंबी दूरी की गाड़ियां गुजरती हैं तथा स्थानीय यातायात के बढ़ने के कारण इस सड़क में होने वाली दुर्घटनाओं में बेतहाशा वृद्धि हुई है। इसमें अक्सर उन निर्दोष लोगों की जानें जाती हैं जो रोजी रोटी या अन्य कार्यों से दोनों शहरों के बीच सफर करते हैं।

अतः आज की परिस्थिति को देखते हुए यह आवश्यक हो गया है कि लंबी दूरी के यातायात के लिये एक अलग सड़क बनाई जाये तथा स्थानीय यातायात के लिए अलग चूंकि एक नई सड़क के निर्माण में भूमि उपलब्धता एक बहुत बड़ी समस्या है तथा इसमें समय भी काफी ज्यादा लगने की संभावना है। अतः यह उचित होगा कि वर्तमान सड़क के ऊपर ही एक लंबा फलाई ओवर बनकर दोनों यातायात को अलग अलग कर दिया जाये जिससे लंबी दूरी का यातायात भी बिना किसी रूकावट के चला जाये और स्थानीय यातायात भी सुरक्षापूर्वक चलता रहे।

(x) Need to amend the forest laws to permit development works in forest areas particularly in Sabarkantha Parliamentary Constituency, Gujarat

श्री महेन्द्रसिंह पी. चौहाण (साबरकांठा): गुजरात के मेरे साबरकांठा संसदीय क्षेत्र के सुदूर ग्रामीण आदिवासी इलाकों में देश की आजादी के वक्त की बनी हुयी सड़कें जर्जर तथा खरताहाल हैं। लेकिन वन विभाग के आदिम कानूनों के चलते इन सड़कों को दोबारा डामर आदि डालकर बनाने की किसी को अनुमित नहीं है। सड़कों का अच्छी हालत में होना किसी भी क्षेत्र के विकास की पहली शर्त है। सदियों से जंगलों में निवास करने वाले आदिवासियों के जीवनस्तर में कोई गुणात्मक सुधार नहीं होने का एक महत्वपूर्ण कारण वहां की सड़कों का अच्छी हालत में नहीं होना है। शायद यही वजह है कि सरकार की आदिवासियों के कल्याण की बहुत सी योजनाएं विफलता की शिकार होती हैं और आदिवासियों के जीवन आंगन में खुशहाली की कोई किरण नहीं पहुंच पाती है। सरकार की तमाम योजनाओं के बावजूद आदिवासी समुदाय की सड़कें दुरूस्त नहीं होने की वजह से जंगली जीवन जीने के लिए अभिशप्त हैं। इन्हीं वन कानूनों के चलते आदिवासी बस्तियों में इंदिरा आवास बनाने की सामग्री, पीने के पानी की पाइन लाइन तथा बिजली के खम्भे लगाने की मनाही है। किसी क्षेत्र के विकास के लिहाज से यह मूलभूत सुविधाएं अति आवश्यक हैं।

अतः सरकार से मेरा अनुरोध है कि पुराने वन कानूनों में मानवीय धरातल पर बदलाव करके बनवासी आदिवासियों के जीवन को बेहतर बनाने का मार्ग प्रशस्त करने की कृपा करें।

(xi) Need to start air service between Agra and metro cities of the country

प्रो. रामशंकर (आगरा): मेरे लोक सभा क्षेत्र आगरा में आजकल प्रतिदिन 50 हजार से 70 हजार तक देशी विदेशी पर्यटक आते हैं। देशी विदेशी पर्यटकों के साथ साथ देशभर से पढ़ने वाले छात्र, जूता उद्योग से जुड़े व्यापारी एवं मथुरा में बड़ी संख्या में दर्शनार्थी आते हें, किन्तु आगरा में हवाई यातायात की स्थाई व्यवस्था के अभाव में उनको बड़ी कठिनाईयों का सामना करना पड़ता है। हमारी मांग है कि आगरा जैसे ऐतिहासिक एवं विश्व धरोहर को देश के प्रमुख मैट्रोसिटी से हवाई यातायात से जोड़ा जाये तथा प्रमुख उड़ानों जेसे दिल्ली से आगरा, लखनऊ, वाराणसी एवं दिल्ली से आगरा, जयपुर, मुम्बई, गोवा, बंगलौर को हवाई यातायात हेतु अविलम्ब आपस में जोड़ा जाये।

(xii)Need to rename Indian High Commissions in foreign countries as 'Embassy of India' and their heads as 'Ambassador of India'

श्री राजेन्द्र अग्रवाल (मेरट): विदेशों में स्थित हमारे राजनियक कार्यालय व राजनियक प्रमुख नामकरण की दृष्टि से दो श्रेणियों में बांटे हुए हैं। कुछ देशों में हम उन्हें क्रमशः उच्चायोग तथा उच्चायुक्त करते हैं जबिक अन्य देशों में दूतावास तथा राजदूत। इन नामभेद का आखिर क्या कारण है तथा इसका क्या उद्देश्य है। स्वाभाविक रूप से उच्चायोग व उच्चायुक्त नामकरण हमें यही याद दिलाता है कि हम अंग्रेजों के अधीन रहे हैं जो सम्पूर्ण राष्ट्रीय मनोविज्ञान में हीनभावना का निर्माण करता है।

मेरा सरकार से अनुरोध है कि इस नामभेद को तुरन्त समाप्त किया जाये तथा सभी देशों में स्थित हमारे राजनियक कार्यालयों को दूतावास तथा अधिकारियों को राजदूत के नाम से जाना जाये।

(xiii) Need to expend Varanasi – Singrauli intercity express upto Shakti nagar and Bapudham express upto Shakti nagar via Chunar and Chopan in Uttar Pradesh

श्री पकौड़ी लाल (रॉबर्ट्सगंज): मेरा संसदीय क्षेत्र 80 राबर्ट्सगंज (उ.प्र.) एक उद्योग प्रधान क्षेत्र है जहां एनटीपीसी की कई परियोजनाएं, एनसीएल की 14 परियोजनाएं, हिण्डालको इण्डस्ट्रीज की तीन परियोजनाएं, रिलायन्स की दो परियोजनाएं, लैंको की परियोजनाएं एवं अनेक छोटी-छोटी परियोजनाएं विद्यमान हैं जो शक्तिनगर रेलवे स्टेशन सेंटर के चारों तरफ स्थापित हैं। अनेक प्रांतों के लोग रोजी-रोटी के लिए आते रहते हैं एवं बसे हुए हैं। यहां आवश्यकता के अनुरूप ट्रेन नहीं चलाई जाती हैं। जिससे जनता को परेशानियों का सामना करना पड़ता है। इस क्षेत्र से केन्द्र एवं प्रदेश सरकार को भारी राजस्व की प्राप्ति होती है। रेलवे संबंधी समस्या निम्न है।

- वाराणसी-सिंगरौली इंटरिसटी ट्रेन संख्या 13345/13346 को वाराणसी से शक्तिनगर चलाया जाए।
 इस ट्रेन की समय सारणी ठीक करते हुए दोनों ओर से 15103/15104 गोरखपुर वाराणसी ट्रेन में
 लिंक कर दिया जाये।
- 2. ट्रेन नं.12537/12538 बापू धाम एक्सप्रेस का मार्ग विस्तार कर चुनार-चोपन होते हुए शक्तिनगर पू.म. रेलवे तक चलाया जाए।

(xiv)Need to impress upon State Governments to set up institutions to look after the educational needs of the children in accordance with the spirit of the Right to Education Act

श्रीमती सीमा उपाध्याय (फतेहपुर सीकरी): देश में 6 से 14 वर्ष के बच्चों को अनिवार्य शिक्षा देने के मामले में शिक्षा अधिकार कानून वर्ष 2010 से लागू है पर बच्चों की शिकायतों पर ध्यान देने के प्रावधान के बावजूद इस पर कुछ राज्यों में अमल नहीं हो रहा है। शिकायतों के लिए राज्य बाल अधिकार संरक्षण आयोग के गठन पर कुछ राज्यों में बच्चों की शिकायतों की सुनवाई के लिए तंत्र स्थापित नहीं किए हैं।

दूसरी ओर देश में कराए गए एक सर्वेक्षण में यह बात सामने आई है कि जो बच्चे प्राइमरी स्कूलों में पढ़ते हैं, वह पांचवी कक्षा तक 2 से 10 तक का टेबल कंठस्थ नहीं कर पाते। रिपोर्ट में यह भी कहा गया है कि वे बमुश्किल शब्दों को जोड़कर वाक्य बना पाते हैं, जो अत्यंत चिंता की बात है।

मेरी मांग है कि गिरते शिक्षा स्तर को सुधारने हेतु एवं बच्चों की शिकायतों को दूर करने के लिए अविलम्ब आवश्यक सभी कदम उठाये जायें, जिससे अध्ययनरत बच्चों को अच्छी शिक्षा प्राप्त हो सके।

(xv) Need to upgrade Simri Bakhtiyarpur, Hasanpur Road and Maheshkhunt in Bihar under East Central Railway as model stations

श्री दिनेश चन्द्र यादव (खगड़िया): बिहार राज्य अंतर्गत पूर्व-मध्य रेलवे के रेल मंडल समस्तीपूर में सिमरी बिख्तियारपुर एवं हसनपुर रोड तथा रेल मंडल सोनपुर में महेशखुंट रेलवे स्टेशन महत्वपूर्ण स्टेशनों में है। यहां से बड़ी संख्या में रेल यात्री यात्रा करते हैं। रेल यात्रियों की सुविधाओं में भारी कमी है।

आग्रह है कि सिमरी बख्तियारपुर, हसनपुर रोड तथा महेशखुंट रेलवे स्टेशनों को आदर्श स्टेशन बनाकर रेल यात्रियों को सुविधा दी जाये।

(xvi)Need to create awareness about the unwanted use of antibiotics and their negative effects on human health.

DR. RATNA DE (HOOGHLY): Of late, banning of controversial drugs has become the order of the day. Recently, the Health Ministry of the Government of India has taken a laudable decision to ban 6 controversial drugs. It is a welcome step. But I would like to pay emphasis on antibiotics, which is a specialized medicine.

The general practice in hospitals and dispensaries is when the fever is not contained, doctor prescribes antibiotics, which is a wrong practice. Only in exceptional cases, antibiotics should be prescribed. Using antibiotics would lead to severe consequences.

Another disturbing trend in all this is pharmacist without prescription gives antibiotics; sometimes patients too indulge in self-prescription, which in many cases result in dangerous situation. Sometimes doctors too prescribe these drugs without understanding the repercussion it would have. Administration of antibiotics in a wrong way should be avoided.

Under the circumstances, I would strongly urge the Union Health Minister to come up with vigorous and sustained campaigning, both in urban, rural and semi-urban areas, highlighting negative impact of antibiotics; penalty should be imposed on manufacturers, pharmacists and doctors too for abusing antibiotics as the same would result in high chances of adverse effects.

(xvii) Need to impress upon the Government of Karnataka to stop the proposed construction of check dam across South Pennar River

SHRI E.G. SUGAVANAM (KRISHNAGIRI): South Pennar River (Thenpennaiyar) which has its origin in Karnataka flows through Madivala, Agaram, Bellandur, Varthur before reaching to Kodiyalam Lake in Tamil Nadu. From here, it reaches to Kelevarapalli Dam in Hosur. Nearly 36,000 acres of cultivable land in Krishnagiri District get irrigation facilities. People of Krishnagiri District mainly depend on this river for drinking water as also for industrial growth. Around 2,000 and 9,000 acres of agricultural land get irrigated through Kodiyalam Check Dam and Kelavarapalli Dam, respectively. KRP Dam, called as the Krishnagiri Dam, also provide irrigational facility to more than 19,000 acres of cultivable land.

South Pennar River supports the cultivation of various seasonal crops like sugarcane, paddy, ragi, cabbage, potato, beans, brinjal, banana, mango and various fruits, flowers, pan, subari, coconut, etc. which form the livelihood of the people of Krishnagiri District.

Although South Pennar River has its origin in Karnataka, it is the only source of water to the entire Krishnagiri District in Tamil Nadu for centuries together.

However, the Government of Karnataka is planning to construct a Check Dam across South Pennar River near Bangalore and has proposed to divert the river water to the State of Karnataka via Varathur and Mindahalli Lakes. If this proposal is implemented, Krishnagiri district would soon become a desert, agricultural lands may become barren and waste lands; and people will struggle for their livelihood and even to get potable water.

I, therefore, urge upon the Union Government to kindly intervene in the matter and direct the Karnataka Government to stop the proposed construction of

Check Dam across South Pennar River (Thenpennaiyar) and ensure that this river water which is entering Tamil Nadu is not diverted to Karnataka.

(xviii) Need to set up a Kendriya Vidyalaya in Jhargram Parliamentary Constituency, West Bengal

SHRI PULIN BIHARI BASKE (JHARGRAM): There is not a single Kendriya Vidyalaya in my Jhargram Parliamentary Constituency (ST). It belongs to Junglemahal which is mostly maoist affected. The Parliamentary Constituency is surrounded by Jharkhand and Orissa. Mostly, people belong to SC, ST and OBC living here who are deprived from education. Government is aware of the fact that there are six Kendriya Vidyalayas in neighbouring Midnapore Parliamentary Constituency. But my Jhargram Parliamentary Constituency has not a single Kendriya Vidyalaya. Availability of land as well as infrastructure is there. Government of West Bengal has declared Jhargram a new district. Unfortunately, people of this area are deprived of higher education. So, I urge upon the Government to set up a Kendriya Vidyalaya at Jhargram to spread education among the SC, ST people at large.

(xix) Need to resolve the issue of share of Rajasthan in water of Yamuna river

डॉ. किरोड़ी लाल मीणा (दौसा): दिनांक 12.5.94 को बेसिन राज्यों हरियाणा, राजधान, उत्तर प्रदेश एवं दिल्ली संघीय राज्यों के मध्य हुए समझौते के अनुरूप राजस्थान को 1.119 बीसीएम यमुना जल आवंटित किया गया। अपर यमुना नदी बोर्ड की 22वीं बैठक जो कि दिनांक 21.12.2001 को आयोजित हुई उसमें राजस्थान का मानसून सत्र में ताजेवाला हैडवर्क्स से 1917 क्यूसेक तथा ओखला हैडवर्क्स से 1281 क्यूसेक यमुना जल का आबंटन किया गया। राज्य ने इस जल को भरतपुर एवं चुरू-झुंझुनूं जिलों में उपयोग हेतु दो प्रस्ताव (कार्य योजना) तैयार की है। केन्द्रीय जल आयोग ने हरियाणा से इस पर सहमति लेने की शत पर इन परियोजनाओं को मंजूरी दी। दिनांक 14.2.03 को हरियाणा राज्य को सहमति हेतु एमओयू भेजा गया था। हरियाणा ने ताजेवाला हैड से यमुना जल के आवंटन पर इस आधार पर असहमति दर्शायी कि ताजेवाला हैड पर आवंटित जल, हरियाणा द्वारा ताजेवाला पर विद्यमान जल के उपयोग की रक्षा नहीं करता है, इसलिए उसने यह प्रकरण अपर यमुना रिव्यू कमेटी को प्रेषित कर दिया।

अपर यमुना रिव्यू कमेटी की दिनांक 12.4.06 की बैठक में राजस्थान को ताजेवाला से जल उपलब्धता के बारे में अपर यमुना रिव्यू कमेटी के निर्णयों के परिपेक्ष्य में इस मुद्दे पर ताजा विचार करने हेतु राजस्थान, हरियाणा, दिल्ली एवं उत्तर प्रदेश, राज्यों के सिंचाई /जल संसाधन सचिवों की एक उच्चाधिकार प्राप्त समिति का गठन करने का निर्णय लिया गया।

हरियाणा एवं राजस्थान राज्यों के बीच ताजेवाला हैडवर्क्स पर पानी की उपलब्धता पर कोई मतभेद नहीं था। दोनों के विचारों में यह समानता थी कि राजस्थान के चुरू एवं झुंझुनूं जिलों के क्षेत्रों को ताजेवाला हैडवर्क्स से पानी उपलब्ध कराया जा सकता है। लेकिन पानी को राजस्थान सीमा तक पहुंचाने हेतु नहरी तंत्र के विषय में सहमति नहीं बन पाई। हरियाणा का विचार था कि राजस्थान वेस्टर्न यमुना केनाल, दिल्ली ब्रांच, जे.एल.एन. फीडर के समान्तर एक नई नहर का निर्माण राजस्थान सीमा तक करके पानी ले जावें। जबकि राजस्थान का विचार था कि ताजेवाला से वेस्टर्न यमुना कैनाल एवं इसकी प्रणाली को रिमोडल करके पानी राजस्थान सीमा तक पहुंचाना तकनीकी- वित्तीय दृष्टि से सर्वश्रेष्ठ रहेगा।

एम्पावर्ड कमेटी ने अपनी अंतिम रिपोर्ट दिनांक 29.12.2007 को केन्द्रीय जल संसाधन मंत्रालय, भारत सरकार को अपर यमुना रिव्यू कमेटी के समक्ष विचारार्थ के लिए प्रेषित कर दी।

दिनांक 19.06.2009 को जयपुर में हरियाणा राज्य की ओर से माननीय मुख्यमंत्री, सिंचाई मंत्री, प्रमुख शासन सचिव, सिंचाई विभाग ने तथा राजस्थान राज्य की ओर से माननीय मुख्यमंत्री, जल संसाधन मंत्री तथा प्रमुख शासन सचिव जल संसाधन, राजस्थान ने दोनों राज्यों के मध्य विभिनन विषयों पर आपसी विचार विमर्श किया। जिसमें राजस्थान में हरियाणा राज्य में से होकर ताजेवाला हैडवर्क्स से यमुना जल लाने के विषय पर विचार विमर्श किया गया एवं तय किया गया कि हरियाणा एवं राजस्थान के प्रमुख शासन सचिव मिलकर राजस्थान को यमुना जल देने हेतु विचार करेंगे। माननीय मुख्यमंत्री, राजस्थान ने अपने पत्र दिनांक 7.4.2010 द्वारा जल संसाधन मंत्री, भारत सरकार से निवेदन किया है कि वे हरियाणा से कहे कि केन्द्रीय जल आयोग से स्वीकृति प्रस्ताव के अनुसार ताजेवाला एवं ओखला बैराज से ही चुरू, झुंझुनूं व भरतपुर जिलों को पानी देने वाली परियोजना रिपोर्ट पर वह अपनी सहमति भेजे। इसी दौरान पत्रांक 15.12.09 के द्वारा मुख्यमंत्री, हरियाणा ने केन्द्रीय जल संसाधन मंत्री से आग्रह किया कि वह अध्यक्ष, अपर यमुना रीवर बोर्ड को निर्देशित करे तथा हरियाणा तथा राजस्थान के मुख्य अभियंताओं की एक बैठक आयोजित करे, जसमें राजस्थान को ताजेवाला की बजाय माबी (जिला पानीपत) पर एक बैराज बनाकर यम्ना जल देने के प्रस्ताव पर विचार विमर्श किया जाये। किन्त्, इस संबंध में दिनांक 13.4.2010 को अध्यक्ष अपर यमुना रीवर बोर्ड ने हरियाणा, राजस्थान, उत्तर प्रदेश तथा केन्द्रीय जल आयोग के मुख्य अभियंताओं की एक बैठक आयोजित की, जिसमें अध्यक्ष, अपर यमुना रीवर बोर्ड ने माबी पर बनने वाले प्रस्तावित बैराज के डूब क्षेत्र में आने वाली भूमि के आकलन का कार्य उत्तर प्रदेश तथा हरियाणा को दिया। माबी पर जल उपलब्धतता के आंकड़ों के आकलन का कार्य केन्द्र जल आयोग को दिया गया। हरियाणा से अभी तक कोई प्रगति रिपोर्ट प्राप्त नहीं हुई है।

अपर यमुना रिव्यू कमेटी की बैठक दिनांक 19.7.2011 को नई दिल्ली में आयोजित की गई, जिसमें राजस्थान की ओर से माननीय जल संसाधन मंत्री, अतिरिक्त मुख्य सचिव, जल संसाधन ने भाग लिया। इस बैठक में विभिन्न विषयों पर विचार विमर्श किया गया। अपर यमुना रिव्यू कमेटी के अध्यक्ष ने कहा कि राजस्थान को ताजेवाला हैडवर्क्स से आबंटित जल के प्रकरण को हरियाणा तथा राजस्थान आपसी सहमित से सुलझाये, यदि जरूरत हो तो इस प्रकरण को सुलझाने के लिए केन्द्रीय जल आयोग की मदद भी ली जा सकती है। अतः केन्द्र इस समस्या का निपटारा शीघ्र करे।
