- (b) the details of the total cost of these projects along with the land acquired for the purpose;
- (c) the average kilometre of the National Highways constructed under other schemes besides PPP mode;
- (d) whether certain companies have monopoly in PPP road projects of the National Highways Authority of India (NHAI) and if so, the details thereof; and
- (e) the steps taken by the Government to frame rules so as to end monopoly in PPP projects?

(a) and (b) The details of projects under implementation on National Highways, State wise, are as follow:-

The total cost of these projects is about Rs. 1,42,550 crores. Land acquisition involved is about 1,00,000 hectares for all the projects.

(c) About 2,988 km has been constructed under non-PPP schemes till October, 2016 in the current financial year.

(d) and (e) The Concessionaires for PPP road projects are appointed through open, transparent and competitive bidding process within the ambit of a pre-defined and approved implementation framework.
