- (a) There are 3686 historical monuments and Archaeological sites declared protected as of National importance by the Archaeological Survey of India(ASI) in the country

- (c) Yes, Madam. Archaeological Survey of India has declared all ASI protected Monuments and Archaeological Sites as 'Polythene Free Zone'. All the field offices of ASI have been directed for necessary compliance. In this regard Secretary (Culture) has also issued a D.O. letter to all the Chief Secretaries of States for their active cooperation for making centrally protected monuments as polythene free zone.
- (d) Most of the monuments were fenced and protected area is defined. Basic tourist amenities such as drinking water, toilet blocks, facilities for physically challenged, pathways, cultural notice boards/signage, vehicle parking, cloak rooms, etc. are being provided at important tourist visited ASI protected monuments.
