Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of sick and closed Micro, Small and Medium Enterprises (MSMEs), the amount of capital invested and the number of workers employed therein during the last three years and the current year, State/UT-wise;
- (b) whether the Government proposes to revive MSMEs in the country and if so, the details thereof;
- (c) the funds allocated/released for the purpose during the said period, State/UT-wise; and
- (d) the other steps taken for rehabilitation/re-employment of the workers affected by sickness/closure of the MSMEs in the country?

STATEMENT REFERRED IN REPLY TO LOK SABHA STARRED QUESTION No. *179 FOR ANSWER ON 28th NOVEMBER, 2016

(a): As per the data compiled by the Reserve Bank of India (RBI) from the scheduled commercial banks, the position regarding number of sick micro, small and medium enterprises (MSMEs) in the country at the end of March, 2013, March, 2014 and March, 2015 is as under: -

March, 2013	2,22,204
March, 2014	4,68,399
March, 2015	4,73,823

State-wise details of sick units reported by Scheduled Commercial Banks for the year ended March, 2016, as informed by RBI, is placed at **Annex I**.

Information on closure among Micro, Small and Medium Enterprises (MSMEs) is collected through conduct of periodic Census of Registered Sector. As per the last MSME Census (Fourth) data collected with reference to base year 2006-07, number of closed MSMEs in Registered Sector is 4.96 lakh. State/UT-wise details are given in **Annex II**.

Information on the amount of capital invested and the number of workers employed in sick and closed MSMEs are not centrally maintained.

(b): Ministry of Micro, Small and Medium Enterprises (MSME) has notified a Framework for Revival and Rehabilitation of Micro, Small and Medium Enterprises on 29.05.2015 to revive and rehabilitate sick MSMEs. RBI has carried out certain changes in the Framework to make it compatible with the existing regulatory guidelines and issued revised Framework to all Scheduled Commercial Banks on March 17, 2016.

(c)&(d): Details of funds allocated/released for revival of sick and closed MSMEs are not centrally maintained. However, as per the data on sick MSMEs compiled by the Reserve Bank of India (RBI) from the scheduled commercial banks, the state-wise number of sick MSEs, potentially viable enterprises and the enterprises under nursing with the amounts outstanding against them as on March 31, 2016 are given in **Annex III**.
