STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF LOK SABHA STARRED QUESTION NO. 200 DUE FOR REPLY ON 29TH NOVEMBER, 2016.

(a) to (e): Yes, Madam. Government of India and the Government of the State of Israel have signed an agreement on 24.12.1993 for cooperation in the field of Agriculture wherein areas like Water and soil management, arid and semi arid crop production, fruit and vegetable production, post harvest and processing technologies, plant and animal sciences including development of dairy branch, plant protection and control, veterinary science, agribusiness, farm mechanization and technology, agriculture training and extension, agriculture research and agro forestry find specific mention.

Under the Agreement, three Action Plans have been agreed upon and during these three phases of Indo-Israel Action Plan, 28 Centers of Excellence (CoEs) for fruits, citrus, pomegranate, sub-tropical fruits, bee-keeping, vegetables, date palm, mango, kinnow and litchi have been sanctioned under Mission for Integrated Development of Horticulture (MIDH). Out of these, 12 CoEs have been commissioned and are providing planting material and training to farmers. Under the Action Plan, more than 200 field officers from States have also been trained in Israel. Israeli experts are regularly visiting India and conducting farm demonstrations of their technologies. The third phase of Action Plan 2015-2018 is being implemented in 21 States.
