- (b) whether the Government has taken initiatives for raising the income of farmers, induction of appropriate marketing of agricultural products, elimination of malnutrition/starvation and unified development of agriculture; and
- (c) if so, the details thereof and the achievements made so far in this regard?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA
STARRED QUESTION NO. 284 DUE FOR REPLY ON 6TH DECEMBER, 2016.**

(a): Government has initiated a wide-ranging agricultural development programme for improvement of economic conditions of the farmers. The programme is primarily focused on: improvement of land, water resources, livestock, fisheries; conservation of flora and fauna wealth and animal genetic diversity; better support services related to science and technology application, agricultural bio-security, weather forecasting, climate change; farm input service management; effective credit and insurance support; strengthening extension, training and knowledge connectivity; assured and remunerative marketing opportunities; better agricultural and animal science, education and research; promoting special categories of farmers, special categories of farming, special regions of farming and group farming; attracting youth to farming profession; and developing enabling public policies and institutions.

(b) & (c): Agriculture is a state subject, and primary responsibility of the state government. Union Government, however, supplements their efforts through various schemes and programmes that, *inter-alia*; aim at removing market imperfections, increasing production and productivity.

An important recent initiative in this regard include launching of National Agriculture Market (e-NAM) portal enabling a pan-India electronic trading, which seeks to network the existing APMCs and other market yards to create a unified national market for agri-commodities. About 250 markets of 10 states have already been integrated with e-NAM and tradable parameters for 69 agri-commodities have been formulated and uploaded on e-NAM portal to assist e-trading.

To address the issue of malnutrition, Government is providing subsidized foodgrains to the weaker and vulnerable sections through PDS under the National Food Security Act.
