**STATEMENT REFERRED TO IN ANSWER TO LOK SABHA STARRED QUESTION NO. 356 FOR 09.12.2016 REGARDING COMPETITION COMMISSION OF INDIA**

(a) The Competition Commission of India (CCI) aims to, keeping in view of the economic development of the country, prevent practices having adverse effect on competition, promote and sustain competition in markets, to protect the interests of consumers and ensure freedom of trade carried on by other participants in markets, in India, and for matters connected therewith or incidental thereto.

(b) The details regarding number of cases examined and decisions taken by the CCI are as follows:

**Anti-Trust Cases:**

(c) & (d) Yes, Madam. CCI has imposed a penalty of Rs.12917.63 Crores in 327 cases. Details are given in Annexure – “A”. Out of the amount of penalty imposed, an amount of Rs.29.49 Crores has been realized, penalty of Rs.10454.08 Crores has been stayed by Competition Appellate Tribunal/High Court/ Supreme Court, penalty of Rs.2427.90 Crores has been dismissed by Competition Appellate Tribunal/High Court/ Supreme Court and penalty of an amount of Rs.6.16 Crores remains unpaid.

(e) Under the provisions of the Competition Act, 2002 the CCI is mandated, inter-alia, to impose penalties and/or issue cease and desist orders in cases of unethical practices such as anti-competitive agreements and abuse of dominance. Necessary actions are taken by CCI for recovery of penalties, as per provisions of the Competition Act, 2002.
