(b) the rate of growth in production and rise in price of medicines during the above period; and

(c) whether a variation in the rate of growth in manufacturing of medicines under the scheduled and non-scheduled categories of drugs has been observed and if so, the details thereof, category-wise?

**Statement referred to in reply to LOK SABHA STARRED QUESTION No. 95 to be answered on 22<sup>nd</sup> November, 2016 regarding Development of Pharma Industry**

(a): As per the Pharmatrac Data available with National Pharmaceutical Pricing Authority and data provided by Pharmaceuticals Export Promotion Council of India (Pharmexcil), a body under the Ministry of Commerce, the Annual Turnover during the last three years is as under:

(b): In turnover terms the Pharmaceutical Industry has registered a growth from 12.01% during the financial year 2013-14 to 28.96 % during 2015-16. For the Pharmaceutical Industry as a whole, there is no monitorable parameter of price increase or decrease. However, according to the provision of Drugs (Prices Control) Order-2013, the manufacturers of the medicines appearing in National List of Essential Medicines-2015 are permitted to increase the Maximum Retail Price (MRP) of these medicines once in a year, in the month of April on the basis of the Wholesale Price Index (WPI) with respect to previous calendar year. The manufacturer of the medicines not listed under National List of Essential Medicines-2015 is permitted to increase the Maximum Retail Price of the medicines not more than ten percent of Maximum Retail Price during preceding twelve months.

(c): No such comparative study has been carried out.
