COMPUTERIZATION OF PDS

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) whether the huge nationwide network of Public Distribution of system is inter-connected through computer if so, the details thereof and if not, the reasons therefor;

(b) whether all the information about the availability of stock of all the items supplied through the PDS is uploaded in the public domain and updated regularly if so, the details thereof and if not, the reasons therefor;

(c) whether there is any proposal to launch Call Centres/Help Desks 24x7 for the consumers to seek any kind of information about the availability to stock or to make any complain against any PDS official/shops regarding their services or otherwise, if not, the manner in which the Ministry proposes to provide the said information to the consumers;

(d) whether the Government has any plan to extend the timeframe of 30.6.2016 for end to end computerisation of the PDS network; and

(e) if so, details thereof, if not, the reasons therefor?

(a): Department of Food and Public Distribution is implementing a Plan Scheme on 'End-to-end Computerization of TPDS Operations' during 12th Five Year Plan (2012-17). Under this scheme, financial assistance has been given for strengthening of infrastructure in the States/UTs. Computers have been installed at District/Taluka offices & godowns. These computers are also connected through SWAN/private leased lines to States/UTs Govt. PDS server. Status of end-to-end computerization of TPDS operations is annexed.

(b): The Component-I of scheme comprises activities namely digitization of ration cards/beneficiaries and other data bases, online allocation, computerization of supply chain management, setting up of transparency portals and grievance redressal mechanisms. As per the information, online allocation has been implemented in 29 States/UTs and Supply-chain has been computerized in 19 States/UTs.

(c): This Department has issued guidelines for setting up of 4-digit common toll free helpline number '1967' across the country and 1800 series toll-free number in all States/UTs. Toll-free helpline numbers are to be set up by each State/UT for grievance registration and redressal. This number would be widely publicized throughout the State/UT. The provision of registration, receipt of acknowledgement and tracking of public grievances would also be available on transparency portal. The online grievance redressal facility/Toll-free helpline numbers have been implemented in all States/UTs.

(d) & (e): The 'End-to-end Computerization of TPDS Operations' scheme is to be implemented during 12th Five Year Plan i.e. 2012-17. Accordingly, all States/UTs have been asked to implement the scheme within the plan period.
