KEROSENE DISTRIBUTION POLICY

1089. SHRI PANKAJ CHAUDHARY:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the policy guidelines being adopted for issuing Kerosene to ration card holders under the Public Distribution System in the country;
- (b) the quantity of kerosene allotted during the last two financial years i.e. 2014-15 and 2015-16, State-wise; and
- (c) whether kerosene is allotted under non-PDS also besides PDS and if so, the areas of its utilisation?

ANSWER

MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

- (a): Government makes Quarterly Allocation of Public Distribution System (PDS) Superior Kerosene Oil (SKO) to States / UTs under the Public Distribution System (PDS) on gross basis for the purpose of cooking and illumination as provided under the SKO Control Order 1993. Distribution of PDS Kerosene within the State to the ration card holders through ration shops / retailers is fully controlled by the State Government.
- (b): State-wise PDS SKO allocation during last 2 years i.e. 2014-15 and 2015-16 is at Annexure.
- (c): Government has allowed States/UTs to draw one month of quota of PDS Kerosene at non-subsidized rates during each financial year w.e.f. 2012-13 for their special needs.
