- (c) the steps taken by the Government for rehabilitation of people living in the slums near railway tracks in Uttar Pradesh; and
- (d) the number of slums near the railway tracks in Uttar Pradesh which are yet to be rehabilitated and the district-wise details thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF UNSTARRED QUESTION NO. 1206 BY SHRI AJAY MISRA TENI TO BE ANSWERED IN LOK SABHA ON 23.11.2016 REGARDING SLUM DWELLERS AROUND RAILWAY TRACKS.

(a) to (d): Most of the encroachments on Railway land are in the approaches of stations in Metros and big cities in the form of slums around railway tracks. The zone-wise details, the data maintained by Railways which also includes Uttar Pradesh, of Railway land retrieved during the last two years and encroachments as on 31.03.2016 are as given below:

Ministry of Railways do not have any policy for resettlement and rehabilitation of encroachers. Rehabilitation on Railway land is not feasible due to Railway's safety constraints/ operational requirements. Ministry of Housing and Urban Poverty Alleviation has been advised by Ministry of Railways that keeping in view Railways' expansion plans, operational and maintenance requirements, and safety of travelling public, the State Government or the Urban Local Body may have to provide alternative sites for settlement and Ministry of Railways cannot contribute towards cost of construction/ land.
