**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF UNSTARRED QUESTION NO.1238 BY SHRI SURESH C. ANGADI TO BE ANSWERED IN LOK SABHA ON 23.11.2016 REGARDING IZZAT PASSES**

**(a): Yes, Madam. Izzat Monthly Season Tickets(MSTs) priced at ₹25/- are issued to persons working in unorganized sectors with monthly income upto ₹1500/- including BPL Card Holders on the production of the prescribed income certificate and residence proof.**

**(b): Zone-wise number of IZZAT MSTs issued during the last three years are as under:**
