(a)&(b): Yes, Madam. The Government has increased the annual cap of sale of coal through State Nominated Agencies (SNA) from 4200 tonnes to 10,000 tonnes by amending New Coal Distribution Policy (NCDP), 2007 on 07.09.2016. The agencies nominated by State Government for the year 2016-17 & 2017-18 are at Annexure. The quantity of coal allocated to State of Jharkhand for the year 2016-17 & 2017-18 is 4.72 lac ton per annum compared to 4.47 lac ton per annum of coal allocated in 2015-16.
