- (a): The details of projects sanctioned under the Scheme for Integrated Textile Park in Gujarat and their current status is placed at Annexure-I
- (b) to (d): Government has received complaint against Vraj Integrated Textile Park, Kheda for violation of conditions of the sanction. It has been alleged that few units are related to non-textile activities. Government has inquired into the complaint and found that three polyfilm units are operating in the park. The SPV has been served with a show-cause notice to immediately relocate the non-textiles firms outside the Textile Park.
