Review of SBM-G

Will the Minister of **DRINKING WATER AND SANITATION** be pleased to state:

- (a) whether the Government has reviewed the progress made under Swachh Bharat Mission-Gramin (SBM-G) after its completion of two years and if so, the State wise details and outcome thereof including Karnataka;
- (b) the amount spent so far on the Mission and the status of work done in each State there under;
- (c) whether the work of construction of toilets has been speeded up after the increase in financial assistance being provided by the Government for each toilets and if so, the details thereof; and
- (d) the details of the monitoring mechanism put in place to ensure the success of the SBM-G and the extent to which it is working effectively?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF DRINKING WATER & SANITATION
(SHRI RAMESH CHANDAPPA JIGAJINAGI)

(a) Ministry of Drinking Water and Sanitation regularly reviews the progress made under Swachh Bharat Mission (Gramin). Sanitation Coverage, which was **42.05%** on **2.10.2014**, has increased to **57.15%** on **21.11.2016**. Total **1,19,745** Villages have been declared Open Defecation Free (ODF) as on **21-11-2016**. Coverage in Karnataka was **41.35%** as on 2.10.2014, which has been increased to **61.10%** as on **21.11.2016**. Detail of States/UTs including Karnataka is at Annexure-1.

(b) State/UT-wise, Central share spent and Individual Household Latrines (IHHL) constructed between 2.10.2014 and 21.11.2016 under Swachh Bharat Mission (Gramin) is at Annexure-2.

(c) Yes, Madam. Against the expected outcome of **50 lakh** individual latrines for the year 2014-15, **58,54,987** latrines were constructed, which is an achievement of **117%** of the target. During 2015-16, **127.41 lakh** toilets have already been constructed against target of **120.00 lakh**. For the year **2016-17**, against the expected outcome of **1.5 crore** individual latrines, **97,54,789** individual latrines (**65.03%**) have been constructed as on **21-11-2016**.

(d) On-line monitoring has been strengthened and transparency increased in the implementation of the Programme of SBM(G) by making all the data including the names and addresses of the beneficiaries of Individual Household Latrines (IHHLs) available in the public domain / on-line monitoring system. A **Mobile application** for uploading photographs of toilets constructed after 2.10.2014 is being developed. A mobile application called **Swachh** also allows citizens to view the progress being made under SBM(G) in any part of the country right upto household level and also rate the cleanliness level of any village. Regular field visits are conducted by the official of the Ministry to get feedback.
