Will the Minister of **DRINKING WATER AND SANITATION**be pleased to state:

- (a) the number of households in rural areas of the country which have been provided Central Assistance of Rs. 12000for the construction of toilets during each of the last three years and the current year along with the details of number of such household toilets built and the number of them under construction during the period, State/UT-wise;
- (b) the funds allocated for construction of public/community toilets in rural areas during each of the last three years and the current year, State/UT-wise;
- (c) the number of public/community toilets built during the said period and those under construction, State/UT-wise;
- (d) whether the Government has carried out an evaluation and monitoring study to check as to whether these households and community toilets have been actually constructed and the funds have been appropriately utilised by the beneficiaries and if so, the details and outcome thereof; and
- (e) the details of the steps taken to prevent misuse of funds in this regard?

- (a) State/UT-wise, number of household which have been provided Central Assistance and constructed Individual household latrines during last three years and the current year is at Annexure-1.
- (b) State/UT-wise, central share expenditure reported on the construction of Community Sanitary Complexes during each of the last three years and in current year is at Annexure-2.
- (c) State/UT-wise, Community Sanitary Complexes constructed during each of the last three years and in current year is at Annexure-3.
- (d)& (e) The Ministry of Drinking Water and Sanitation has developed a comprehensive system of monitoring of the Programme through visit of Ministry officials and National Level Monitors An on-line monitoring has been strengthened and transparency increased in the implementation of the Programme of SBM(G) by making all the data including the names and addresses of the beneficiaries of Individual Household Latrines (IHHLs) available in the public domain / on-line monitoring system. A **Mobile application** for uploading photographs of toilets constructed after 2.10.2014 is being developed. A mobile application called **Swachch**app also allows any citizen to view the progress made under SBM(G) in any part of the country right uptothe household level.
