(a): The Ministry of Micro, Small & Medium Enterprises has launched ASPIRE (A Scheme for Promoting Innovation, Rural Industry and Entrepreneurship) scheme to accelerate entrepreneurship and to promote start-ups for innovation and entrepreneurship in agro-industry. Under the scheme, there is no laid down criteria for allotment of Livelihood Business Incubators (LBI) and Technology Business Incubators (TBI) to States nor the Ministry allocate any State-wise target for setting up LBIs and TBIs.

(b): Details of the LBI/TBI sanctioned to the various States including Odisha is placed at **Annexure-I**.
