Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the details of facilities being extended to Scheduled Castes/Scheduled Tribes and Other Backward Classes (OBC) students in the country, State-wise;
- (b) the amount sanctioned and released by the Government for this purpose during each of the last three years and the current year including Bihar, State/UT-wise; and
- (c) the details of amount spent on meals to SCs, STs and OBC students studying in residential schools of Bihar, District-wise?

**MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT
(DR. MAHENDRA NATH PANDEY)**

(a) & (b): The facilities being extended to Scheduled Castes(SC), Scheduled Tribes(ST) and Other Backward Class (OBC) Students in the country are through various schemes. The details of schemes and amount sanctioned and released for the purpose during the last three years and current year including Bihar, State/UT wise, provided by concerned Ministries / Organisations is as per details Annexure –I.

(c): The district-wise details of amount spent on meals in Jawahar Navodya Vidyalayas (JNVs) for last three years and amount sanctioned for 535 Kasturba Gandhi Balika Vidyalayas (KGBVs) for the last three years and current year in Bihar is at Annexure-II (a) & (b) respectively.

Annexure-I

I. The following Schemes pertaining to SC students are implemented by M/o Social Justice & Empowerment:-

- (i) Centrally Sponsored Scheme of Pre-Matric Scholarship for SC students studying in Class IX/X (Pre-matric IX and X), to support education of SC students with parents falling within income ceiling of Rs. 2.00 lakhs p.a.
- (ii) Centrally Sponsored Scheme of Post Matric Scholarship for SC students. PMS (SC) to support education of SC students with parents Income ceiling if Rs. 2.50 lakhs p.a.
- (iii) Centrally Sponsored Scheme of Pre-Matric Scholarship to the Children of those engaged in occupations involving cleaning and prone to health hazards No income ceiling.
- (iv) Central Sector Scholarship Scheme of National Overseas Scholarship for SC etc. candidates to support education of SC students with parent's income ceiling is Rs. 6.00 lakhs p.a.
- (v) Central Sector Scheme of National Fellowship for SC students to pursue higher studies such as M.Phil and Ph.D. Implemented through UGC. No income ceiling prescribed.
- (vi) Scheme for Free Coaching for SC and OBC students to support education of SC students with parent's income ceiling Rs. 6.00 lakhs p.a.
- (vii) Central Sector Scheme of Upgradation of Merit for SC students (in classes IX to XII) (provides facilities to upgrade merit by education in residential and non-residential schools).
- (viii) Central Sector Scholarship Scheme of Top Class Education for SC students (for SC students for pursuing study beyond 12th class.). Total income ceiling of family from all sources should not exceed Rs. 4.50 lakhs p.a.
- (ix) Under Babu Jagjivan Ram Chhatrawas Yojna (BJRCY) provides Central Assistance for creation of hostel facilities to SC boys and girls studying in middle schools, higher secondary schools, colleges and Universities to the State Governments/UT Administrations, Central/State Government institutions/NGO/Deemed Universities.
- (x) Assistance to voluntary Organisation working for the welfare of SCs wherein Grants-in-aid is released to NGOs/VOs working in the field of education, healthcare, skill development etc.
- (xi) Pre-Matric Scholarship for OBCs
- (xii) Post-Matric Scholarship for OBCs
- (xiii) Construction of Hostels for OBC Boys and Girls
- (xiv) Assistance to Voluntary Organisations working for welfare of OBCs National Fellowship for OBCs
- (xv) Dr. Ambedkar Scheme of Interest Subsidy on Educational Loans for Overseas Studies for Other Backward Classes (OBCs) and Economically Backward Classes (EBCs).

II. The following schemes pertaining to Scheduled Tribes are implemented by Ministry of Tribal Affairs:

- (i) Pre Matric Scholarship Scheme for ST students to support education of ST students whose parent's annual income is below Rs. 2 Lacs.

- (ii) The Post Matric Scholarship Scheme to support education of ST students at Post Matriculation level including technical and professional studies whose parents annual income is below Rs. 2,50,000/-.
- (iii) National Overseas Scholarship to provides financial assistance to selected students 17 ST, 3 particularly vulnerable Tribal Groups, to pursue Post Graduation, PhD and Post Doctoral study abroad, fellowship is given to the students whose total annual income along with the income of the parents doesn't exceed Rs. 6 Lacs.
- (iv) Scheme of Top Class Education for ST students, to ST students for pursuing studies and degree at Post Graduate level in any of the 158 identified institutions of excellence such as IITs, NIITs, IIMs etc.
- (v) Rajiv Gandhi National Fellowship Scheme for ST students: Under this scheme 750 fellowships are provided to the ST students each year for pursuing higher studies in India for MPhil and PhD. Fellowship amount is as per UGC norms for a period of 2 to 5 years.

III. The following Schemes pertaining to SC/ST/OBC students are implemented by Ministry of Human Resource Development:

D/o School Education & Literacy, M/o Human Resource Development:-

(1) Under Centrally Sponsored Scheme of Sarva Siksha Abhiyan facilities are being extended to SCs, STs and OBCs at elementary level for text books, uniform, mid day meals, fee reimbursement, Kasturba Balika Vidhyalya which have residential facility within upper primary schools Swach Vidhyalya initiative. The Details of total fund released under SSA for SC and ST component during last three years and current year are as under:

(2) The Rashtriya Madhyamik Shiksha Abhiyan(RMSA) scheme provides for enhancing the enrolment for classes IX-X by providing a secondary school within a reasonable distance of every habitation, improving quality of education imparted at secondary level through making all secondary schools conform to prescribed norms, removal of gender, social-economic and disability barriers, 90% of GER by 2017, and universal retention by 2020 for the following components in SC, ST concentration districts- New Schools, Strengthening of schools, Girls Hostel, ICT in

school and Vocational Education. Under Centrally Sponsored National Scheme of Incentive to Girls for Secondary Education (NSIGSE):-The Secondary Scholarship Division of Department of School Education and Literacy is administering a centrally sponsored scheme namely “National Scheme of Incentive to Girls for Secondary Education (NSIGSE)’ to promote enrolment of girl students mainly belonging to SC/ST communities at secondary level and reduce the drop-out rate by providing Rs.3,000/- as fixed deposit on enrolment in class IX in a State Government, Government-aided and Local Body schools, who are entitled to withdraw it along with interest thereon on passing X Class and attaining 18 years of age.

(3) Kendriya Vidyalaya Sangathan provides 25% seats in class 1 at entry stage to the children belonging to SC/ST/OBC non creamy layer /EWS/BPL/differently abled category children. and ensures admission upto 15% for SC and 7.5% for ST in fresh admission, no tuition fee is charged from children belonging to SC/ST category.

(4) Jawahar Navodaya Vidyalayas run by Navodaya Vidyalaya Samiti provide a system of alternate schools for gifted students including those belonging to SC/ST and OBC.

Department of Higher Education, M/o Human Resource Development

(i) UGC has been implementing various scholarship/fellowships schemes wherein financial assistance to selected candidates belonging to SC/ST categories is provided for pursuing Post-Graduation, M.Phil./Ph.D. and Post-Doctoral research and on full time/ regular basis in Universities/Institutions/Colleges in India. Many of these schemes are funded by Ministry of Social Justice and Empowerment and Ministry of Tribal Affairs and implemented by UGC :-P.G. Scholarship for Professional Courses for SC/ST candidates, National Fellowship for Scheduled Castes Students, National Fellowship for Higher Education of ST Students, National Fellowship for Students of Other Backward Classes (OBC, Post-Doctoral Fellowship for SC/ST. The beneficiaries of these schemes are paid fellowship on DBT platform by designated branches of Canara Bank through Public Financial Monitoring System (PFMS).

(ii) Central Sector interest subsidy scheme on education loans (CSIS) provides interest subsidy is given to economically weaker sections of the society i.e. to the students whose parental income is up to Rs. 4.5 lakhs per annum.

In schemes under D/o Higher Education funds are released through nodal agency-UGC/designated bank and not to States /UTs.

The amount sanctioned and released state-wise in respect of other majors scheme is attached at Annexure I(a) to I(m).
