SPECTRUM AUCTION

Will the Minister of COMMUNICATIONS be pleased to state:

(a) the details of revenue earned by the Government through auctions of spectrum conducted during the last six years, auction-wise including targets fixed and results achieved;

(b) the details of the recently conducted auction, along with number of participants, quantum of airwaves put on sale and upfront payments received by the Government;

(c) whether the auction ended well below the target and there were no takers for premium 700 MHz. and 900 MHz band of spectrum;

(d) if so, the details thereof and the reasons therefor; and

(e) the steps taken by the Government for better outcome in the next auction along with the time frame for the next auction and the spectrum likely to be put on auction with estimated revenue target?

(a) The details of revenue earned by the Government through auctions of spectrum during last six years are as follows;

As regards auction-wise target fixed and result achieved, it is submitted that as such no specific targets were fixed from spectrum auction. Only Reserve Price (RP) of each band of spectrum in each Licensed Service Area (LSA) put to auction, had been fixed by the Govt. on the recommendation of TRAI.

However budgetary target projection by DoT can be taken as the revenue target from spectrum auction.

The year-wise figures of revenue projection by DoT for budget purpose and actual revenue realization against that target are as follows:

Total number of Participants were 7 i.e. 1. M/s Reliance JIO, 2. M/s Bharti Airtel, 3. M/s Idea Cellular, 4. M/s Vodafone, 5. M/s Tata Teleservices, 6. M/s Reliance Infocomm. & 7. M/s Aircel.

(c) & (d) No bid was received in any of the 22 LSAs and 4 LSAs in 700 MHz and 900 MHz bands respectively. Absence of ecosystem in 700 MHz band including the non-availability of devices together with industry perception of high reserve price appear to be the main reason for no bids in the 700 MHz band. Availability of small blocks of spectrum in 900 MHz band resulted in no bids in this band. In addition, companies appeared to be preserving cash to protect market share in the days to come.
