(b) & (c): No inconvenience to the passengers has been caused since only fares have been rationalised and no major changes have been made in the booking/cancellation system. Comparative total vacant berth in Rajdhani, Shatabdi and Duronto trains for the period 09.09.2016 to 31.10.2016 vis a vis 09.09.2015 to 31.10.2015 are as under:-

(e): At present, there is no proposal to withdraw the flexi fare system in Rajdhani, Shatabdi and Duronto trains since there has been substantial increase in the operating cost of the Railways over the past few years.
