EXPANSION OF POSTAL NETWORK

†2337. SHRI ARJUN LAL MEENA:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the Government has reviewed the expansion of postal network and delay in setting up of post offices in the country;
- (b) if so, the details and findings thereof;
- (c) the details of proposals pending for approval alongwith the approved number of post offices facing delay in their setting up, State-wise; and
- (d) the action taken by the Government to expedite the process of setting up of new post offices?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF COMMUNICATIONS & MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MANOJ SINHA)

- (a) Review of expansion of postal network is an on-going process. If found justified, as per laid down norms, post offices are opened on the basis of relocation & redeployment under Plan Scheme. New post offices are opened against plan targets in a given financial year, and there is no delay in opening of post offices.
- (b) Does not arise in view of (a) above.
- (c) State/UT-wise number of proposals received during current financial year 2016-17 (upto 07.11.2016) for opening of new post offices, proposals pending for approval and proposals approved for opening of new post offices but facing delay in opening are at **Annexure.**
- (d) New post offices are opened after following the prescribed norms and procedures against plan target within the financial year.
