No.2439 SHRI AJAY NISHAD:

Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) whether the Union Government provides funds to municipalities for water supply and management;
- (b) if so, the details thereof and the basis on which municipalities are selected;
- (c) the number of municipalities which have been provided funds during each of the last three years and the current year, State-wise; and
- (d) the level upto which implementation of these schemes is monitored and the number of municipalities which have achieved the set target under the scheme?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (RAO INDERJIT SINGH)

- (a) to (b): The Central Government has launched the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) to strengthen the urban infrastructure including water supply in the 500 Mission Cities. The Mission cities under AMRUT include all cities with population over one lakh, some cities on stem of main rivers and a few capital cities and important cities located in hills, islands and tourist areas.
- (c): Under the Mission, the Central Government approves the State Annual Action Plans (SAAPs) of States and UTs and releases the funds. The individual projects are prepared, appraised and implemented by the concerned State Government/UT Government in accordance with the Mission Guidelines. Funds are not released ULB-wise. Details of State-wise amounts approved by the Ministry in first and second SAAP for projects in water supply sector is given in Annexure.

(d) The Mission provides for regular monitoring through field visits, review meetings and video conference etc. It is also monitored through Quarterly Progress Reports, utilisation certificates, reports and through Independent Review and Monitoring Agencies (IRMA). Besides, the States/ Urban Local Bodies are also engaged in monitoring the progress.

The Mission was launched in June, 2015 for a period of five years and the targets for the Mission are designed to be achieved by March, 2020.
