Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the details of funds allocated, released and spent by the Non-Governmental Organisations (NGOs) during the last three years, State/UT-wise and scheme-wise;
- (b) the names and amount of funds received by NGOs which have received financial assistance under the ongoing rural schemes during the last three years and the current year along with the amount of assistance received in Madhya Pradesh; and
- (c) the names of NGOs which have been found involved in irregularities?

(SHRI RAM KRIPAL YADAV)

(a): Under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), assistance of Civil Society Organizations (CSOs), identified by the State Government, are taken to support the Gram Panchayats under Cluster Facilitation Teams (CFT) project. State/UT-wise details of funds released to the State Governments under CFT project and Non-Governmental Organisations (NGOs) under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) and Mahila Kisan Sashaktikaran Pariyojana (MKSP) during the last three years is given at **Annex-I**.

(b): Funds released to the NGOs operating in Madhya Pradesh under DDU-GKY are given at **Annex-II**.

(c): One NGO, namely, Sitapur Shikshan Sansthan Trust, Uttar Pradesh, bearing Permanent Registration Number UP2013RT1180 has been blacklisted by the Ministry.
