- (b) if so, the details thereof, category, department and institution-wise along with the steps taken to fill up these vacancies;**
- (c) whether the Government proposes to take the advantage of social media networking including Twitter handles for grievance redressal; and**
- (d) if so, the details thereof and if not, the reasons therefor?**

**(a) & (b) The vacant posts are filled up as per the laid down procedure, as and when vacancy arises. The vacancy position in the Ministry of Corporate Affairs Headquarters, Regional Directorates, Offices of Registrar of Companies, Offices of Official Liquidators, Competition Commission of India and Serious Fraud Investigation Office is given in the Annexure. Apart from efforts to fill up vacant posts in these organisations/ institutions as per laid down procedure, the following additional steps are taken by the Ministry:**

- (i) Relaxations have been provided in the Recruitment Rules, whenever deemed necessary.**
- (ii) Appointment of consultants and staff is done on outsourcing basis.**
- (iii) Officers are deployed on loan basis to organisations/ institutions.**

**(c) & (d) The MCA21 system is being used for effective monitoring and redressal of grievances along with CPGRAMS portal, and social media can be tapped for creating public awareness.**
