The sector wise information on Foreign Direct Investment (FDI) is available only for FDI equity inflows and is given at **Annexure-I**. FDI Data is not maintained state-wise, but RBI regional office wise. FDI equity inflow recorded for a particular regional office of RBI may cover more than one State. Accordingly, region wise details of FDI equity inflow are at **Annexure –II**.

(b) & (c): One proposal of M/s Crown Cement Manufacturing India Pvt Ltd involving FDI of Rs. 15.5 crore in Assam has been filed on 27th September 2016. Filing of FDI proposals is a continuous process which are placed before FIPB only after examination of the proposals from FDI Policy angle and compliance with requirements.
