Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government has received proposal from Madhya Pradesh under the Scheme of Implementation of persons with Disabilities Act, 1995 (SIPDA) during the year 2015-16;
- (b) if so, the details thereof;
- (c) whether the Government has given its approval on the proposals received; and
- (d) if not, the reasons therefor?

ANSWER MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT

(SHRI KRISHAN PAL GURJAR)

- (a), (b) and (c): Yes Sir. The Status of proposals received from Madhya Pradesh during the year 2015-16 under the Scheme of Implementation of persons with Disabilities Act, 1995 (SIPDA), is given in the **Annexure-I**.
- (d) Out of five proposals received during 2015-16, Grants-in-aid was released in respect of one proposal. Grants-in-aid could not be released in respect of four proposals due to receipt of incomplete proposals and due to non-submission of Utilization Certificates for Rs.9.15 lakh for the year 2009-10, for Rs.48.97 lakh for the year 2010-11 and Rs.702.25 lakh for the year 2014-15, by the Government of Madhya Pradesh, despite reminders dated 25.06.2014, 6.8.2014. 14.1.2015, 23.12.2015, 18.2.2016, 2.3.2016, 4.8.2016, 9.6.2016, 27.7.2016 and 1.9.2016. - Such a situation is unwarranted as the funds are not being released for new proposals and utilized for the benefits of the persons with disabilities, in compliance with the Persons with Disabilities Act, 1995.
- It is pertinent here that this Department has launched Accessible India Campaign. Financial proposals in this regard are also being submitted by the State Governments for release of funds under the SIPDA Scheme of the Department. The progress of the Accessible India Campaign is also being monitored by PMO in Pragati/Dash Board. Non-submission of pending Utilisation Certificates is a stumbling block for this Campaign.
- I shall therefore request you to impress upon the concerned Department for furnishing the Utilisation Certificate in respect of the grants-in-aid and the Progress Report about the work done so far.
