SHORTAGE OF COMMUNITY CENTRES

No. 3542 SHRI KAUSHAL KISHORE:

Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) whether there is a shortage of community centres/barat ghars in various Government colonies in Delhi and if so, the details thereof and the reasons therefor;
- (b) whether the Government has received requests from various quarters for construction of community centres/barat ghars in Government colonies and also construction of additional rooms in Government flats;
- (c) if so, the details thereof and the action taken/being taken by the Government in this regard;
- (d) whether parks are not being allotted in various Government colonies including horticulture zone-I, Delhi for marriage and other religious purposes; and
- (e) if so, the details thereof and the reasons therefor along with the remedial action taken/being taken by the Government in this regard?

ANSWER

- (a) to (c): Action for construction/reconstruction of community centres/barat ghars as recommended by Department of Personnel and Training and on requests for construction of additional room in Government colonies made by allottees/Residents Welfare Association (RWAs) is taken up by Central Public Works Department (CPWD) subject to feasibility. The details are annexed.
- (d) & (e): Parks are allotted for marriage and other religious purposes in terms of guidelines issued by Ministry of Urban Development.
