Drinking Water Projects in Tribal and Backward Areas

Will the Minister of DRINKING WATER AND SANITATION be pleased to state:

- (a) the details of ongoing/proposed projects to improve availability of drinking water and sanitation facilities in tribal and backward areas in the country, State-wise including Jharkhand;
- (b) the funds sanctioned/allocated for various tribal areas in the country including Jharkhand, State/UT-wise; and
- (c) the current status of drinking water availability and sanitation standards in the tribal belts in various States across the country, State/UT-wise?

ANSWER MINISTER OF STATE FOR DRINKING WATER AND SANITATION (SHRI RAMESH CHANDAPPA JIGAJINAGI)

- (a) The State-wise details of ongoing / proposed schemes under National Rural Drinking Water Programme (NRDWP) in Schedule Tribesdominated habitations in the country including Jharkhand is at **Annexure-I**.
 - The Swachh Bharat Mission (Gramin) has been launched on 2nd October, 2014, which aims at attaining Swachh Bharat by 2nd October 2019. Currently SBM(G) is under implementation in **147** tribal-dominated districts. State-wise, number of tribal-dominated districts where SBM(G) is under implementation at **Annexure-II**.
 - The Ministry does not maintain the detail separately for backward areas.
- (b) The State / UT-wise details of funds sanctioned / allocated under NRDWP for Schedule Tribesdominated habitations during current yearin the country including Jharkhand is at Annexure-III.
 - TheState/UT-wise, Central share released in Schedule Tribes (STs) dominated districts during current year under SBM (G) as per the information available on the online Integrated Management Information System (IMIS) of SBM(G) is at **Annexure-IV**.
- (c) The State / UT-wise details of current status of drinking water availability in Schedule Tribesdominated habitations in the country are at **Annexure V**.
 - The State/UT-wise, Sanitation Coverage in Schedule Tribes (STs) dominated districts as on 5.12.2016 as per the information uploaded by the States concerned on the IMIS of SBM(G) is at **Annexure-VI**.
