- (e) whether the Government has ordered a high level inquiry into use of sub-standard material in construction of roads and other irregularities in various States including UP; and
- (f) if so, the details thereof, State and NH-wise?

(a) The details of the National Highway projects which are sanctioned during the last three years are at Annexure-I

(b) 3169, 7972 & 10098 km of contracts were awarded during the last three years 2013-14, 2014-15 and 2015-16 respectively.

(c) to (d) About 316 numbers of projects are delayed mainly due to due to land acquisition, utility shifting, non availability of Soil/Aggregates, Poor performance of contractors, Environment/ Forest/Wildlife Clearance, ROB & RUB issue with Railways, Public agitation for additional facilities, Arbitration/contractual disputes with contractors etc

(e) to (f) Two enquiries are going on in Telangana state on NH No. 221.
